The purpose of the notice board is to provide neighbors with a visual tool to evaluate the proposed construction.

Before your application is ready for noticing, you must provide evidence that the notice board has been posted.


Notice Board

Board Size: At least 2 feet by 3 feet, weatherproof

Post Size/Board Height: Minimum 5 foot tall, 2"x 4"

Duration of Posting: From start of noticing period until action has been taken on the application and after the appeal period has passed.

Notice Board Content (IN MINIMUM 24 POINT FONT):

- Exact address of the property, if known, or the location if address is unknown.
- At least one perspective drawing or three-dimensional (3D) photographic simulation, minimum 11"x17" in size black and white or color.
- Project summary for proposed scope of work:
 - Lot size in square feet,
 - Building coverage,
 - Total building area (including garage and detached structures),
 - First floor and second floor square footages,
 - Ratio of second floor to first floor area,
 - Second floor side yard setbacks, and
 - Floor area ratio.

Include the following text:

"Deadline for submission on public comments: [Date, confirmed by Project Planner] An electronic copy of the full plan set is available by request.
