
ORDER VACATING SUBMISSION AND
RESUBMITTING CAUSE

The merits hearing on this petition for writ of mandate occurred on December 19, 2019, and the matter was then submitted. The Court requested a copy of the reporter's transcript of the hearing and that was provided on February 6, 2020. The Court now vacates submission of the cause and finds good cause to do so based on the Covid19 health care crisis with which the court is dealing,

1 which going forward for at least the next three weeks will mean only essential court operations with
2 strictly reduced levels of court functions and employees. Also contributing to good cause are the
3 complexity of the issues in this case presenting emerging issues of law and the volume of briefing.
4 Accordingly, submission of the cause is hereby vacated and the matter is resubmitted as of today's
5 date. The Court has every hope to issue its orders in this case (one on the scope of the record and
6 one on the merits) as soon as it is reasonably possible to do so.
