New Voice over Internet Phone (VoIP) System

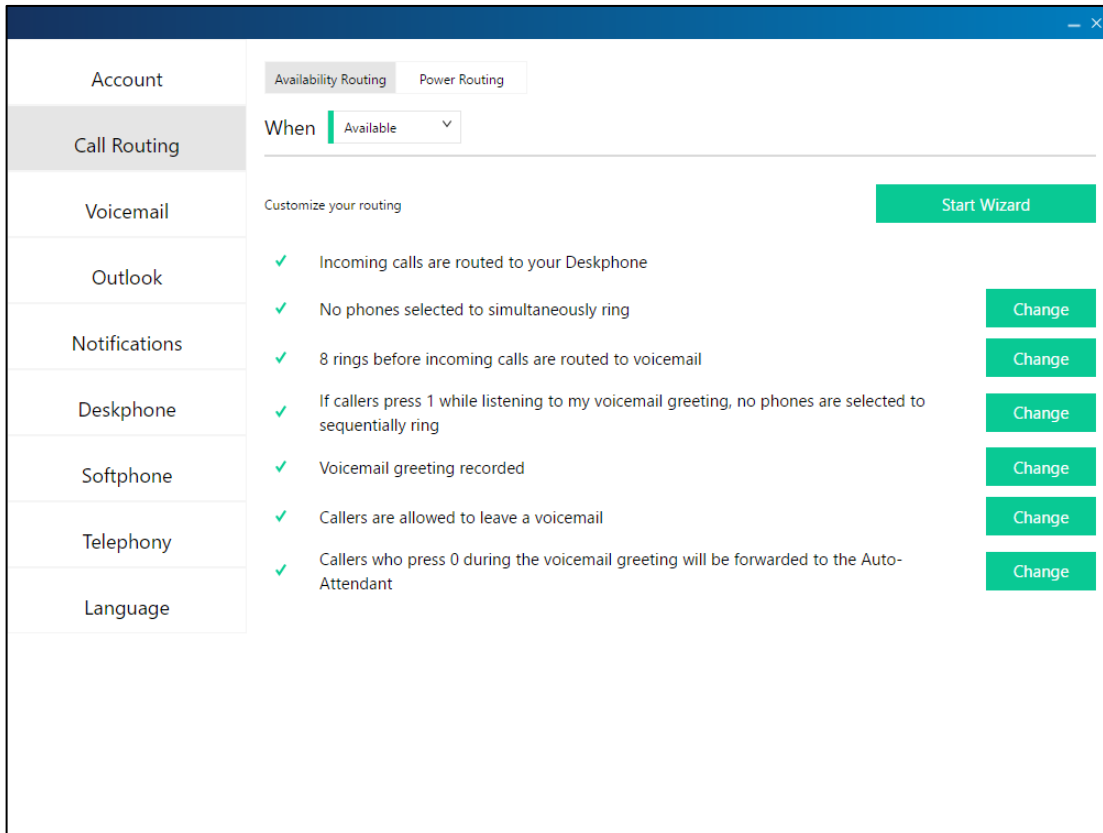
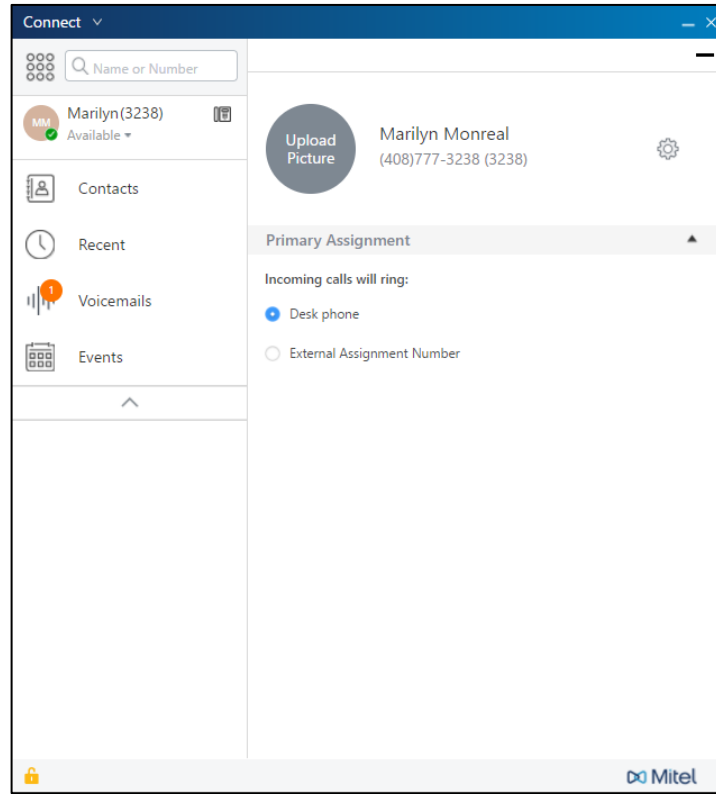
The Innovation Technology department is pleased to announce the deployment of the new Voice over Internet Phone (VoIP) system this Thursday, April 25.

As part of the new VoIP system, the Mitel Connect application allows users to manage their phones from their computer, a sample dialog box is included below. The new VoIP system has an Outlook feature that allows users to sync their Exchange Calendar with Mitel Connect, and switch availability state accordingly (i.e. In a Meeting).

Users have the option to opt out, if they wish.

Additional features include Call routing, Voicemail notification, and Call history logs.

This is the latest initiative in IT's ongoing effort to provide quality, cost-effective technical solutions.



Employee Photo for the Active Directory

The Innovation Technology department has completed the Employee Photo Project.

The Video division took a simple and short photo of employees, and worked with IT to upload the final picture into the Active Directory.

The photo is an added security measure to assist employees in identifying phishing emails. Additionally, this will aid staff in recognizing new employees.

On Saturday, April 20, 2019, the City of Cupertino held the annual Big Bunny 5K and Kids Fun Run at the Cupertino Civic Center. 911 participants, ages 3 months to 87 years, took part in either the 5K race or Kids Fun Run. Jonathan Kimura was the top male finisher with a time of 16 minutes and 17 seconds and Hannah Papazian had the top finish for a female participant with a time of 18 minutes and 45 seconds. This is a fun, family-oriented event that has become a tradition in many households and promotes a positive, healthy, connected community.



<hack> Cupertino 2019

On April 13-14, the Recreation & Community Services Department, together with the Cupertino Teen Commission, hosted the third year of <hack> Cupertino, a 13-hour overnight hackathon for young innovators, aspiring coders, and developers to bring their ideas to fruition. "Life hacks" was the theme of this year's event and participants were tasked with designing a website, software, or application that would bring ease to or streamline an aspect of everyday life. One-hundred and fifteen (115) local teens coded throughout the night to come up with a creative solution while participating in educational workshops, recreation activities, ping-pong tournaments, and much more. The three top winning projects were *The Right Price*, *TinoWalks*, and *FaceAttend*. Judges included Vice Mayor Liang Chao, Neesha Tambe from the Parks and Recreation Commission, Naidu Bollineni and Arnold de Leon from the TIC Commission, Gaurav Khot a Chief Architect at ShoCard, and Recreation Supervisor Kim Calame. Winners will be recognized at the May 7 City Council meeting.
