### Community Feedback on Environmental and Sustainability Webpages and ReThink Disposable Program

The City of Cupertino received a letter from a resident expressing praise for the City's environmental and sustainability webpages, specifically referencing the ReThink Disposable program. Operated by the Clean Water Fund, the ReThink Disposable program identifies opportunities for restaurants, cafés, and cafeterias to reduce waste and save money by using reusable foodware products for dine-in eating instead of single-use disposable items. The County of Santa Clara has partnered with the Clean Water Fund to implement the ReThink Disposable program in all county jurisdictions, including Cupertino. Two restaurants in Cupertino, Erik's Delicafe and House of Falafel, have participated in the program.

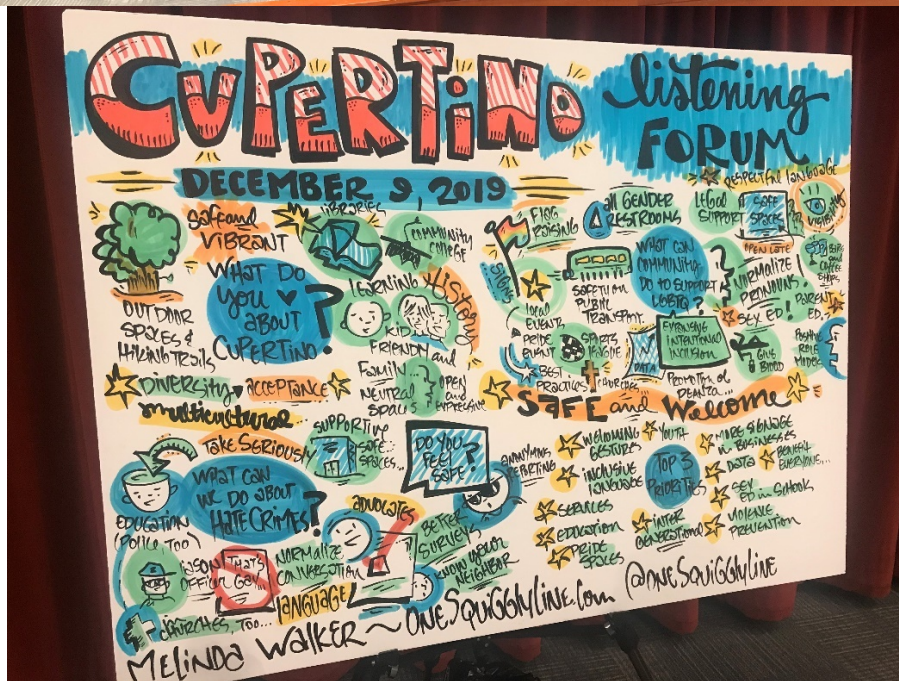




## LGBTQ+ Listening Forum in Cupertino Most Well-Attended in the County

The Santa Clara County Office of LGBTQ Affairs hosted the last stop on their Listening Tour in Cupertino on Monday, December 9, 2019. These community forum events were held in various cities throughout the County. The forum provided an opportunity for residents to share their feedback on the best ways that the County, the City, and the community can all work together to support and improve the quality of life for LGBTQ+ residents in Cupertino.

The LGBTQ Listening Forum in Cupertino was the most well-attended of all the events in the County, with over 20 members of the public participating in the discussion exercise along with City and County officials. Some ideas discussed included providing opportunities for education, hosting more local Pride events, and increasing visibility in businesses and public facilities. During the event, artist Melinda Walker illustrated a poster reflecting the points that were being discussed.



## Cupertino Café

The Youth Activity Board (YAB) and the Parks and Recreation Department hosted the fall session of the 'Cupertino Café', a four-day event that gives teens a dedicated place to study and crunch for final exams while being able to socialize, participate in recreation activities, and enjoy complimentary snacks. Community Hall was opened by Parks and Recreation staff, and mobile recreation activities were set up to give students a brief respite from their studies and unwind by playing a game of corn hole, ping pong, foosball, or various board games. A new feature of the *Cupertino Café* introduced during this session were themed days which included the following themes:

- Late Night College App Work Session – seniors were invited to complete their college applications in a quiet setting.
- Friendship Bracelets & Scratch Card Art – event-goers were able to take a break with these therapy crafts.
- Therapy Bunnies – attendees were able to take a break with these furry critters provided by the Cupertino Library.

Additionally, the Parks and Recreation Department partnered with the Cupertino Library to advertise the event and to help reduce weekend traffic at the library. This is the latest effort in creating ways for teens to de-stress from school, socialize with their peers, and educate them on the positive value of recreation. Across 4 days, the *Cupertino Café* served over 300 teens.





## Tree Lighting 2019

On Friday, December 6, the Parks and Recreation Department hosted Cupertino's annual Tree Lighting event, at the Quinlan Community Center. Due to the rain, this outdoor event was moved completely indoors. The event included musical entertainment from Business Casual—an award-winning a cappella group, crafts, hot chocolate, cookies, a movie, balloon animals, and a visit from Santa. Special thanks to the Santa Clara County Fire Department for bringing Santa and his Elf to Quinlan on a fire engine.

Tree Lighting could not happen without the support of the Public Works Department. A huge thank you to the Tree Division for hanging the lights on the Quinlan tree. This is not an easy task, but they did an outstanding job! The tree looks absolutely beautiful!





## Breakfast with Santa 2019

The 28th Annual Breakfast with Santa event was held on Saturday, December 7, at the Quinlan Community Center. Over 300 participants enjoyed a morning of holiday cheer. The De Anza Optimist Club of Cupertino, along with over 26 teen volunteers, supported staff to provide a wonderful pancake/sausage breakfast, letter writing to Santa at Santa's Post Office, and a variety of holiday-themed crafts for the Cupertino community. Na' Hoalooha Ho'okani Pila provided a wonderful musical performance and set the mood for the spirit of the holidays. The highlight for many children and families was having their picture taken with Santa...a lasting memory for all! We hope to see all again next year!





## Signing Santa

On Saturday, December 14, the Parks and Recreation Department introduced a unique holiday event – Signing Santa! This event was the first of its kind in the Bay Area and provided an opportunity for deaf and hard of hearing children to talk to Santa using American Sign Language (ASL).
