Safe Routes to School Video PSA: Avoiding Right Hooks

Cupertino's Safe Routes to School program, in collaboration with the Transportation Division and Office of Communications, published a public service announcement video with safety precautions that cyclists and motorists should take while traveling down the separated bike lanes on McClellan Road.

Cupertino's Enterprise Content Management Roadmap

At the beginning of this year, Cupertino hired an experienced Enterprise Content Management contractor to develop a three-year roadmap of Laserfiche—the City's document management system and repository for storing electronic records. The ECM contractor will determine where the implementation of Laserfiche currently stands, where it should be, and outline the strategy to get there. The goal was to develop a plan to manage and manipulate enterprise content to drive specific business practices and outcomes. Content will no longer be a passive resource, filed away awaiting retrieval. Instead, improvements will be made to the current infrastructure, streamlining Laserfiche to enhance the existing processes and applications to drive decision-making, establish connected workflows, trigger actions within the connected multiple-tier applications network, and become self-policing. This will reduce cost, waste, and variation with information-based processes.

The three-year strategic plan outlines:

- How Cupertino will move from a departmental siloed system to an enterprise-wide ECM structure that allows for Google searching capabilities and third-party integration
- Expansion into other Departments
- Organizational ECM policies and procedures, and metadata model
- Roadmap for business automation and provide and provide for future ECM scalability

Projected impacts to the City:

- People – The time spent searching for documents is reduced, the results the users encounter are accurate, and in-turn user reliance on the system will increase. Expanding Laserfiche to the Departments not currently using the system will reduce the paper storage and increase efficiency in storing and retrieving documents.
- Processes – Creating an organization-wide structure, naming conventions, and metadata standards will improve the speed and accuracy of search results in Laserfiche. Setting standard policies, as well as documenting and training on the guidelines for inputting and editing of documents, will improve consistency and reliability in the system.
- Technology – Creating an organization-wide folder and data structure in Laserfiche will allow enterprise applications to integrate more quickly and seamlessly. This will enable scalability and provide a system that can grow with the organization. Using workflow to automate processes, implementing import agents to capture metadata from documents upon import, and exploring the mobile app for use by operations staff in the field are some tools and modules Laserfiche offers that the City will be able to take advantage of.

Cupertino's Innovation Technology Department is already underway making changes to the system to move toward to above stated goals. Please note due to these changes, the metadata tab will be removed from the Laserfiche public portal. The reason for this is to eliminate any confusion regarding the "update date" displayed in the metadata. The system has no way to show the public whether the change occurred in the metadata fields, template, document, or folder structure. A detailed audit trail of the changes that have been made to a document is available upon request.

Holiday Banners and Median Lighting

In preparation for the upcoming holiday season, Public Works staff has completed the installation of 100 holiday banners throughout the City. Below are the locations that the banners can be seen. Holiday lighting has also been placed on the medians on Stevens Creek and De Anza Boulevards. The lights were turned on after this past Thanksgiving Holiday and will remain on during the evening until after New Year's Day.

- N. Stelling Road in front of the Quinlan Community Center
- Stevens Creek Boulevard from Stelling Road to De Anza Boulevard
- De Anza Boulevard from Bollinger Road to Hwy 280
- Torre Avenue east side from Pacifica Drive to Rodrigues Avenue

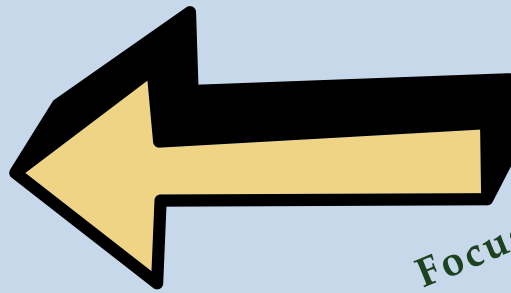
