Youth Activity Board Kickoff

On Sunday, January 13 Cupertino's inaugural members of the Youth Activity Board (YAB), a newly formed group by the City's Recreation Department and the Teen Commission, participated in their Kickoff Social. They engaged in an escape room activity designed to begin building the collaborative nature of the group. The YAB was formally created in September 2018 with the purpose of creating activities for youth and teens and encouraging them to de-stress and socialize. To achieve their vision, the YAB will work with Recreation staff and the Teen Commission to develop ideas, implement youth and teen programs, and encourage youth and teen involvement in their community. With the newly formed YAB, the City has added another invaluable resource in addressing youth and teen mental health.







Second Annual City of Cupertino Spelling Bee

On Saturday, January 12 the City of Cupertino hosted its second annual Spelling Bee for $4^{th}-6^{th}$ graders. Twenty-five students came from across different Cupertino schools and engaged in a fierce, educationally enriching competition for the honorary title of the Cupertino Spelling Bee champion. After thirty intense rounds, 6^{th} grader Sriya Pidaparthi was crowned champion with the winning word "Hibiscus," and 5^{th} grader Shivansh Kelkar being the runner-up. Environmental Recycling Day and Shred It Event

The first "Environmental Recycling Day and Shred It Event" of 2019 was held on Saturday, January 19 between 9 a.m. and 1 p.m. at De Anza College. This quarterly event is sponsored by Recology to offer Cupertino residents a no-charge opportunity to shred confidential documents and drop off other unwanted materials for responsible reuse and recycling. Common items received are gently used clothing, plastic toys and play structures, yard trimmings, kitchen appliances, universal waste (batteries, CFLs, and fluorescent tubes), construction and demolition debris, and electronic waste. 503 residents participated in this popular event and found purposeful reuse opportunities for many items no longer needed in their homes. Other totals of materials collected that day were:

• 3.8 tons of construction and demolition materials

- 1.5 tons of organic (yard) materials
- 9.5 tons of personal documents shredded
- 3.7 tons of electronic and universal waste
- 1 full 26-foot flatbed of clothing, toys, and household items were donated to Goodwill.

This event is a key component to Cupertino and Recology's vision of a Zero Waste community by keeping materials out of the landfill, providing gently used items to folks in need, and recycling other types of waste. There will be three more of these events this calendar year which are scheduled for April 13, August 17, and November 9.

Classics and Cookies Concert

The Senior Center held its first Classics and Cookies Concert on Friday, January 25, from 5 p.m. to 6:30 p.m. The event offered the opportunity for members and the general public to enjoy an hour-long program presented by the Harker Tri-M Music Group. Performers ranged from 6th-12th grade and they performed an array of songs from the Beatles to Mozart. After the concert, the audience had a chance to engage with the performers over light refreshments and the performers even played happy birthday to an audience member who was turning 85.







Youth Mental Health First Aid

In order to address growing youth stress and become more prepared in managing emotional or mental crises, Teen Center staff attended a Youth Mental Health First Aid course designed for adults who work with young people ages 12-18. Staff learned a five-step action plan to offer initial help to young people showing signs of a mental illness or in a crisis, and connect them with the appropriate professional, peers, social, or self-help care. Conversational guidelines and different types of mental health disorders were covered within the course, and staff are now better equipped to aid a teen in crisis.

Public Works Lead Worker Jason Fauth becomes Certified Arborist

Maintenance Worker Lead Jason Fauth has worked for the City of Cupertino since 2007. He has served in the Streets Division, the Trees/ROW Division, and on both the median maintenance crew and the tree maintenance crew. In Jason's current role as the Maintenance Worker Lead for Tree Maintenance he evaluates trees for maintenance needs, follows up on citizen requests, trains employees and collaborates with other divisions and departments in order to create and sustain a safe environment for our citizens to enjoy. Last month Jason passed his Certified Arborist exam. Though this achievement in not a requirement of Jason's position, it demonstrates his professionalism and dedication to the service he provides to our community.



City Implementation of State Water Board PCB Screening Requirement

On January 24, 2019 the City adopted a management policy to implement a required regional PCBs (Polychlorinated Biphenyls) screening program in advance of building demolition. The program targets specific materials in buildings which were constructed or remodeled between 1950 and 1981 and exempts single-family homes and wood framed structures. Adoption of this

policy is required by the City's Municipal Regional Stormwater Permit (MRP) which is shared with 76 other Bay Area cities, counties, and districts. The Environmental Programs Division is administering the program and have provided outreach to those impacted. Resignation of Fine Arts Commissioner

Commissioner Ran Wu notified staff of her resignation from the Fine Arts Commission effective February 13, 2019. Council appointed Ran as a second alternate during the January 2018 appointment process. She filled Commissioner Wenjia Chen's unexpected vacancy on March 26, 2018. Ran Wu's resignation email is attached. Sonia Dhami will fill the unexpired portion of Ran's term which will end on January 30, 2021. Council appointed Sonia as a first alternate during the recent commission interviews.

Public Thank You

<u>Public Email:</u> "I don't live in Cupertino, but I want to compliment and thank you for your city's street signs. I deliver meals for Meals on Wheels in San Jose, Campbell, Los Gatos, Saratoga, Morgan Hill and Cupertino and your signs are, by far, the easiest to read. That makes a big difference to someone not familiar with the area. I say "thank you" every time I go out."

Cupertino street name signs:

In the late 1990s Cupertino chose blue as the standard color for their street name signs. 5" letters are used for the street name and 3" letters for the supplemental designation such as Rd., Ave., Ct., etc. A 9" aluminum blank is used to fabricate these signs. The majority of the residential street name signs are produced using these specifications. The overhead street name signs on the arterial and collector streets are much larger as vehicles are traveling at a higher rate of speed. These larger signs will be found on streets such as De Anza Blvd., Stevens Creek Blvd., Miller Ave., Wolfe Rd., Tantau Ave., Foothill Blvd., Homestead Rd., Stelling Rd., McClellan Ave. and Bollinger Rd.

The initial installation of the new street name signs began in 1999/2000. Public works maintenance staff focused their efforts on the main arterial and collector streets throughout Cupertino. Once these streets were completed, maintenance staff replaced the street name signs in the residential neighborhoods. This initial phase was completed in 2011 with all street name signs having been replaced throughout Cupertino. The life of the material used for the signs varies from 7 to 10 years.

City street maintenance staff recently completed an 18-month project replacing all of the overhead street name signs on the arterial and collector streets. As part of the routine maintenance performed by the street maintenance staff, the remaining residential street name signs will again be replaced as the 7 to 10 year life cycle of the sign ends.

Cupertino's Public Works Street Maintenance Division has a dedicated sign shop and staff responsible for the design, fabrication, installation and maintenance of over 10,000 signs. These include roadway regulatory, warning, and guide signs. The City's inventory includes 2,700 street name signs. There are many custom signs made for the City parks, parking lots, City buildings, and facilities.
