# **Sports Center Open House**

The Cupertino Sports Center's Open House was held on January 12 and included free fitness classes, facility tours, and face painting for the kids. A Sports Center T-shirt and reusable grocery bag were given to the first 300 people through the door and the popular raffle included certificates to various local businesses, department recreation programs and Sports Center memberships. The Cupertino Tennis Club was present to promote the USTA. Over the past month, the Sports Center has sold 541 memberships through their Open House Special.

# January 16, 2019 Storm Event

The January 16 storm event required numerous Public Works responses throughout the City.

Public Works crews responded to minor localized flooding events. Staff inspected each of these locations and removed materials that were obstructing drain inlets. After the material was removed, any pooling water quickly subsided.

A small slide occurred along Stevens Canyon Road (see attached photo). The debris was removed from the roadway, and staff placed sandbags across the base of the slide area to prevent further debris from entering the roadway. Though it does not appear further material will slide, staff will continue to monitor the situation.

Additionally, the City received 23 separate notifications regarding downed trees or tree limbs (13 caused by public trees and 10 by private trees). Public Works crews worked throughout night to promptly remove materials from the right of way. The only damage reported due to falling limbs was a broken fence rail at the McClellan Ranch Preserve parking lot.

A storm drain pipe on Regnart Road became decoupled, causing storm water to scour the adjacent slope (see attached photo). Public Works will reattach the pipe and work to make the necessary permanent repairs.

The storm also caused two poles, which support netting along the 8<sup>th</sup> hole at Blackberry Farm Golf Course, to fail at their base (see the attached photo). Public Works crews inspected the other four poles along this stretch of the course and noticed each of the poles showed signs of degradation. Staff removed all six poles in order to prevent future failures at this location. No other damage to public facilities occurred.

The majority of clean-up activities were completed by the end of business on Thursday, January 17.

Attached are messages from residents submitted through CitySourced acknowledging staff's efforts.

#### McClellan Ranch West Parking Lot Improvement

The capital improvement project to construct a "green," meadow-style parking lot at McClellan Ranch West is scheduled to begin this month. On October 16, 2018, City Council authorized the award of a construction contract to Galeb Paving, Inc. (GPI). GPI was the lowest responsive bidder out of five bids received for the project.

Over the years, the McClellan Ranch West site has been used informally for staff and overflow parking without a suitable, stable surface, and is not available for use during the rainy season due to mud. Further, the opening of the Environmental Education Center in 2015 has increased the parking demand at McClellan Ranch Preserve. The demolition of the Simms House three years ago at the McClellan Ranch West site advanced the option to build the additional parking needed at McClellan Ranch Preserve. Designed by SSA Landscape Architects and Underwood & Rosenblum Engineers, the improved parking lot will have 27 parking stalls on permeable concrete paving with future capacity for overflow parking for about 20 cars. Wildlife-sensitive, amber-colored LED site lighting, and native plants and grasses will be installed in order to have minimal impact to the site and be sensitive to the creek environment.

The construction contract is for \$605,083 and the project is anticipated to be completed by June 2019.

#### Newsom Proposes Sweeping Changes on RHNA, Housing Elements

Attached please find an article from the California Planning and Development Report (CP&DR) article related to potential changes to the RHNA and Housing Elements proposed by Governor Gavin Newsom in a bid to increase housing production. The proposal includes carrots in the form of \$750 million to local governments in funds and sticks including withholding transportation funds, if housing goals are not met. While details have not been provided, changes in general terms include:

- \$750 million on housing, including \$250 million for planning
- A complete revamp of the state's RHNA and Housing Element process with a change in HCD's role from being advisory to overseeing and enforcing housing production.
- \$500 million for the development of moderate-income housing
- Expansion of the state low-income housing tax credit program (LIHTC)
- Expansion of the use of state's surplus property for affordable housing since this would not require local approval
- Changes to the Enhanced Infrastructure Finance District program

The Council will be informed as and when new legislation is proposed or guidelines are issued by the state.

# **CASA Compact Update**

The CASA, Committee to Housing the Bay Area, Compact was finalized on December 12, 2018. The Metropolitan Transportation Commission (MTC) authorized Chair Jake Mackenzie to sign on to the CASA Compact at its December 19, 2018 meeting (<a href="https://mtc.ca.gov/whats-happening/news/housing-policy-leaders-endorse-strategy-ease-bay-areas-housing-affordability">https://mtc.ca.gov/whats-happening/news/housing-policy-leaders-endorse-strategy-ease-bay-areas-housing-affordability</a>). At its January 17, 2019 meeting, the Association of Bay Area Governments (ABAG) authorized President David Rabbitt to sign the CASA Compact (<a href="https://blog.bayareametro.gov/node/28816">https://blog.bayareametro.gov/node/28816</a>). It is anticipated that this will form the basis of new state legislation. # Youth Civic Engagement Forum

The Teen Commission and the newly formed Youth Activity Board, together with the Recreation and Community Services Department, hosted the Youth Civic Engagement Forum on Tuesday, January 22 in the Quinlan Community Center. The intent of this platform was to give youth and

teens opportunity to provide input on the citywide Parks and Recreation System Master Plan, which will guide the City's development, renovation, and activation of City parks, recreation facilities, and trails for the next 20+ years. More than 50 local youth attended the forum and provided staff with integral feedback on the Master Plan.

#### Teddy's for Tots

Since 2016, City staff has participated yearly in "Teddy's for Tots by Castilia," which was started by the daughter of a Community Development Department staff member. The program provides teddy bears and stuffed animals for patients at the Lucille Packard Children's Hospital at Stanford for distribution on Christmas Day (photo attached). The program each year organized the community to generously donate over 400 toys. Each bear was given out to children staying at the hospital and to those coming in that day for emergency services. The hospital has recognized Teddy's for Tots as part of its giving campaign this year.

The goal for 2018 was an ambitious 600 bears to collect. Combined with the help of the City of Cupertino, friends, family, businesses (Kendo, Lockheed-Martin, She-She Shoes), and schools (Garden Gate Elementary), an amazing 803 stuffed animals were collected. The children and families, and especially Lucille Packard Children's Hospital, are very thankful for all of those in the community who have given to this wonderful charity.

#### Adopt-a-Family

Staff members in the Community Development Department gave back this holiday season by participating in the Bill Wilson Center's Adopt-a-Family 2018 Holiday Giving Program. Through the Adopt-a-Family Program, the Bill Wilson Center links donors with Santa Clara County foster youth and families who would otherwise receive few, if any, gifts for the holidays. City staff sponsored three foster families with a total of one care giver and 14 children ranging from 2 to 17 years of age. Staff delivered gifts to the Bill Wilson Center in Santa Clara on December 3, 2018 (photo attached). This year, the Bill Wilson Center and Adopt-a-Family participants donated gifts to almost 2,000 local foster youth and their support families!

# Newsom Proposes Sweeping Changes on RHNA, Housing Elements

CP&DR Staff on Jan 11, 2019 Next

In <u>his first budget proposal</u> Thursday, Gov. Gavin Newsom proposed an unprecedented series of <u>carrots and sticks</u> that would attempt to both induce and force local governments to plan for – and produce – more housing. The proposals could potentially have a wide-ranging impact on the state's system of planning and development, but the budget contained little detail on how these ideas would be implemented.

The biggest carrot is \$750 million to local governments -- \$250 million to up their game on housing elements and \$500 million as a reward for building more housing. In the budget summary, Newsom said the state would revamp the Regional Housing Needs Assessmente process and give the Department of Housing & Community Development a more significant role in enforcing regional housing goals.

The biggest stick – but one that will be difficult to achieve – is his proposal to withhold transportation funds from local governments that don't achieve housing production goals. In his freewheeling budget press conference Thursday, Newsom said: "If you're not hitting your goals, I don't know why you get the money." (Although Liam Dillon's *Los Angeles Times* article on Friday is good source for the overall picture, his live Twitter feed from Thursday gives a vivid real-time account of how Newsom talked about housing at the press conference.

Though the budget summary does not include details on how Newsom will implement his proposed new carrots and sticks, it does lay out a sweeping set of changes in general terms. These include:

- The \$750 million for local governments on housing, including \$250 million for planning.
- A complete revamping of the state's RHNA and Housing Element process under the direction of HCD. Maybe the most important words in the budget summary on this topic are these: "HCD will be taking a more active role in housing element reviews. Moving from an advisory role, HCD will now oversee and enforce regional housing goals and production. HCD will determine a methodology for allocating housing needs to regions and local jurisdictions, with local input."
- \$500 million for the development of moderate-income housing.
- A vastly expanded state low-income housing tax credit program.
- An ambitious proposal to use the state's own surplus property for affordable housing especially since development on such land does not require local approval.
- Modest changes to the Enhanced Infrastructure Finance District program, including eliminating the voter requirement and pairing EIFDs with federal Opportunity Zone investment opportunities. Newsom stopped short, however, of a proposing a new or expanded tax-increment program to benefit housing.

To Jeff Milkes,

We are writing to you to express our concerns regarding the dog park situation in Cupertino, which we have recently found simply dismal and disappointing. In our opinion, one dog park, the Mary Avenue Dog Park, is not enough to satisfy the needs of dog owners across the city. We kindly request that more dog parks be built in the city of Cupertino, so that both pets and pet owners may enjoy what the local community has to offer.

Some of our collective concern comes from personal experience. Julia, for example, owns a dog that is extraordinarily anti-social, due to the fact that it was not able to interact with other dogs at a young age. Transportation across the city to the Mary Avenue Dog Park was simply not a viable option for her family, and given that there were no alternatives, the dog, named Pokey, has had almost no interaction with other dogs and continues to have trouble with this. We have found that situations like this one also pose a valid threat to other community members and pet owners because since the dog is not used to interacting with others, he often unpredictably frightens or attacks other animals that he encounters. We emphasize that it is more than likely that other pet owners are experiencing the same thing, which would completely deter them from or even inhibit their ability to take their pets out in public. In the interest of the safety of other pet owners, specifically ones with pets currently in earlier stages of development, we would like to strongly emphasize the crucial importance of animals' social interactions, which having more dog parks would provide.

Dog parks are not only a place for dogs to interact and get some exercise; they also have many other benefits for the pet owners that visit them. Spending time outdoors in dog parks allows people to take a break from their days and get some fresh air, which can help them both physically and mentally. The parks also provide an opportunity for dog owners to meet and socialize with each other, allowing them to make connections with other people in their community and also potentially exchange tips, ideas, and information about pet ownership. This, again, is extremely valuable to first-time dog owners or owners of younger pets who may not have had prior experience to owning their first pet independently. Dog parks can even be beneficial for people who do not own dogs. They can visit the parks to simply get some fresh air and exercise themselves or to become more comfortable with animals if they may have fears or uncertainties.
