# **Regional Housing Needs Allocation Annual Progress Report**

As part of the <u>Housing Element Open Data Project</u>, the CA Department of Housing and Community Development (HCD) released an <u>online interactive map</u> showing each jurisdictions' compliance with the Annual Progress Report submittal and Progress Towards Regional Housing Needs Allocation (RHNA).

Cupertino is part of the record 86 percent of California's cities and counties that have submitted state-mandated annual progress reports on housing for 2018, according to HCD. The annual progress report captures the number of building permits issued and planning entitlements approved annually by income category. Obtaining planning entitlement allows the developer to submit building permit for review. Once a building permit is issued, construction of the project is likely to occur. Even though the vast majority of cities and counties are not approving enough housing to meet their planning targets, Cupertino has entitled 3,190 units, above and beyond the housing needs allocation of 1,064 units, or approximately 200% above the housing allocation. In 3 of the 4 income categories, Cupertino has far exceeded the RHNA obligations.

On the following page is a summary of Cupertino's compliance and progress.

# Citywide Wi-Fi Network Upgrade Phase I

The Innovation Technology's Infrastructure Division completed the first phase of a Wi-Fi Network Upgrade for all City facilities. The project involved upgrading existing Wi-Fi network equipment at City Hall, Quinlan Community Center, Civic Center common area, Sports Center, Senior Center, McClellan Ranch, and the Service Center. Additionally, new Wi-Fi Networks were added to Blackberry Farm, Blackberry Farm Golf, Monta Vista Recreation Center, and the new HR office located at Town Center Lane. Phase II of the project is scheduled for late Summer/early fall and consists of Wi-Fi Access at Memorial Park and Blackberry Farm picnic areas.

# **Tree Planting on Cristo Rey**

On June 29, 2019, the Public Works' Trees and Right of Way Division and students from Fremont Union High School District, in a joint effort, planted new trees along the Cristo Rey Drive between Oak Valley Road and the Rancho San Antonio Park entrance. Peyton Carroll from Fremont High School coordinated with the Public Works Department and the other volunteers to initiate the project. The Public Works Department's Ricardo Alvarez, Frank Villa, and Adrian Sanchez helped to prepare the site, and to establish and provide drip irrigation for the new trees. Additionally, the Tree Crew helped to educate the students on how to properly plant a tree. The event successfully planted a number of trees and was a great learning experience for all involved. The volunteers had expressed an interest in further opportunities to plant trees with the City's Tree Crew.



# Fourth of July Celebration

The Fourth of July holiday celebration in Cupertino was a great success. The De Anza Optimist Club of Cupertino served their traditional pancake breakfast at the Quinlan Community Center. In partnership with the Boy Scout Troop 476, the Parks and Recreation Department held a Flag Raising Ceremony at the Veteran's Memorial. The Flag Raising was then followed by a Children's Parade that was led by Uncle Sam. The Children's Carnival area included bounce house slides, and a face painting area. The kids loved the slides and the staff did an amazing job at face painting. The Amphitheater was packed with people enjoying live music by The Arena Band.

Blackberry Farm had 426 Cupertino residents and 357 non-residents at the pools for a relaxing holiday. New this year was a steel drum band that filled the pool area with music from the islands. On site were also the "Takoz Mod Mex" and "Just Mix Eat" food trucks. The park was filled with Independence Day guests enjoying a lovely holiday afternoon.

In the evening, the Parks and Recreation Department, along with the Public Works Department, Santa Clara County Sheriff's Office, Santa Clara County Fire Department, Cupertino Citizen Corps, Cupertino Union School District, Creekside Community Church, and the West Valley Presbyterian Church, collaborated to present the annual fireworks celebration. Streets were closed at 5 p.m. for safety purposes as the fireworks were prepared. The viewing sites, Creekside Park, Creekside Community Church, Sedgwick Elementary, and Miller Avenue were well attended by community members. After the show, the Public Works staff had streets re-opened by 10:30 p.m.
