# Optimist Club "Respect for Law" Public Safety Officer of the Year – Gulu Sakhrani and Deputy Chris Scott

## Grant Awarded to Cupertino's Office of Emergency Services

As a way to increase Cupertino's ability to respond quickly and effectively to our community's needs during an emergency, Cupertino's Office of Emergency Services (OES) was awarded \$16,500 in grant funding through Santa Clara County Office of Emergency Management. This grant will allow us to enhance our Emergency Operations Center's computer and technology capabilities. A portion of this funding will also allow OES staff to attend additional training to allow us to better understand the best ways to respond to an emergency, provide protection to our community members, and return our City to a sense of normalcy after an emergency.

## **Compost Site Staffing Challenges**

An unexpected loss of staffing at the compost site has resulted in part-time staffing vacancies. The process to fill the vacancies started about one month ago and only two applications have been received to date. Of the two applicants, only one appears to be a potential interview candidate. Finding and retaining part-time staff for this program has historically been a challenge. As of May 24, a temporary staffing solution that includes one existing part-time employee each Friday and Saturday (7:30 a.m. to 12:30 p.m.) and a full time Service Center staff working overtime each Friday and Saturday (7:30 a.m. to 12:30 p.m.) has been implemented. It is anticipated that this temporary staffing solution will continue for up to another three months until additional part time staff can be hired. The compost site operates each Friday and Saturday (weather permitting) between 8 a.m. and noon March through October.

## Blackberry Farm Entrance Road Improvements – Feasibility Study

The City has started the feasibility study to improve pedestrian and bicycle access to Stevens Creek Trail from San Fernando Avenue.

As a part of the Bicycle Transportation Plan, the Stevens Creek Bike Boulevard route starts at the intersection of San Fernando Avenue and Orange Avenue, which is the road leading to the Blackberry Farm entrance, and proceeds west through the Blackberry Farm Park to connect to the Stevens Creek Trail and Scenic Circle. The Stevens Creek Bike Boulevard connects to the McClellan Bikeways to the south and to the Foothill Bike route to the East. These links to the east and west bike movements would be safer and more scenic for bicyclists than riding on a heavily travelled and high speed road like Stevens Creek Boulevard. This project is prioritized as a Tier 3 project in the 2016 Bicycle Plan and a Tier 2 project in the 2018 Pedestrian Plan.

Currently, the access to Blackberry Farm for bicycles, pedestrians, and vehicles varies from 18 to 24 feet. This width is too narrow to be shared by all that are using various modes of transportation.


The feasibility study that has started will identify, evaluate, and estimate the costs for the various options to improve the safety of all visitors to the park and the trail. The study will enlist a consultant to evaluate the proposed options and develop other options to improve pedestrian and bicycle access to Stevens Creek trail via San Fernando Avenue.

Viable options that the consultant will consider include:

- 1. Widen the roadway to accommodate a two-way street one lane in each direction with an approximately 8-foot wide shared bike and pedestrian path on both sides.
- 2. Widen the roadway to accommodate a two-way street one lane in each direction with an approximately 5-foot wide pedestrian path on one side and a 6-foot bike lane on the uphill side of the road.
- 3. Keep the existing roadway width and install signals or signs that regulate the one way movement in either direction with an approximately 4-foot wide path on both sides.
- 4. Keep the existing roadway width and install a 10-foot wide path with switchbacks starting from the City owned property at 10301 Byrne Avenue and ending at the Blackberry Farm Retreat Center.

Consultant selection is currently proceeding and the time to complete the feasibility study is estimated to be 6-10 months depending on the complexity and level of development of the various options. Completion of this project will provide the needed information to inform Council on the potential effect of the City owned "Sievert" property at the corner of San Fernando and Byrne Avenues. Input into the feasibility study will be solicited from the both Park & Recreation Commission and the Bike & Pedestrian Commission. Once the study is completed, both commissions will be asked to review prior to presentation to Council. The allocated budget approved by Council for the feasibility study is \$75,000.

## New Street Sweeping Contractor to Sweep City Streets

The current multi-year street sweeping contract with Contract Sweeping Service, Inc. expires June 30. Due to the possibility that street sweeping services may be enhanced if the stormwater ballot initiative is successful, staff has solicited street sweeping vendors for a short-term three-month agreement. This three-month period will provide the time needed to know the results of the stormwater ballot at the Council meeting of July 16 and then how to proceed with new multi-year agreement that will be presented to Council prior to October 2019.

Two vendors responded to the solicitation and Clean Street, Inc. was found to be the lowest responsive vendor. Consequently, Clean Street will begin providing services on July 1. Prices have increased significantly for these services compared to the same three-month period in 2018. The Clean Street bid for services beginning on July 1 and ending September 30 is \$63,807. This compares to \$48,420 to Contract Sweeping Service for same time period in 2018. It is expected that the next five-year agreement will have monthly pricing significantly higher than what has been paid in the past.

## Neighborhood Meeting for Larry Way and Randy Lane Street Light Project

Public Works will be hosting a neighborhood meeting for the property owners along Larry Way and Randy Lane, north of Merritt Drive. The meeting will be held on Wednesday, June 26 from 6:30 p.m. to 7:30 p.m. at Cupertino Community Hall (10350 Torre Ave). Staff will discuss the proposed street light infill project, and will gather comments and input from the attendees. The current plans are to have seven City standard metal street light poles installed along Larry Way and Randy Way—that will bridge the gaps between the existing street lights in the neighborhood. The proposed street lights will bring these two streets into alignment with the City's street light spacing guidelines. The neighborhood has no sidewalks due to a semi-rural designation that was approved in 2003. Pedestrians must walk along the road, and additional street lights are being considered in order to enhance safety for pedestrians.

Some residents have expressed interest in having additional street lights throughout the neighborhood, while others have opposed the introduction of additional City standard metal poles. Staff will listen to concerns, and may introduce an informal vote to the property owners on whether to proceed with constructing the project.

## TEDx Youth@Torre Avenue

The Cupertino Teen Commission and Cupertino Library Teen Advisory Board partnered together for the first time to organize the TEDx Youth@TorreAve event, a local, self-organized event designed to bring people together to share a TED-like experience. Six teens were selected to inspire discussion and show teens that they can make an impact in the community through novel ideas and help fill the creative gaps created by misinformation and social barriers. Teen speakers were as follows: Ashley Kang, a student art enthusiast; Eesha Ramkumar, founder of Kids Who Kode and a local student raising awareness about Autism; Janvi Prasad, with her "Different Approach to Feminism" talk; Pranjal Mishra, a gender equality advocate; Sripad Sureshbabu, a student interested in antibiotic-resistant bacteria; and Stuti Upadhyay, a student raising awareness about Hepatitis B.
