Silicon Valley Clean Energy Launches All-Electric Showcase Awards

SVCE encourages owners, developers, builders, architects, and designers of all-electric properties to apply for a cash prize through its <u>All-Electric Showcase Awards</u> program. The prizes range from \$2,000 - \$5,000 depending on the property type. Winners will be featured in case studies that promote all-electric living. The All-Electric Showcase Awards are part of SVCE's FutureFit Homes initiative that encourages fuel-switching away from natural gas appliances to high-efficiency electric technologies. These programs support the City of Cupertino and other SVCE member communities in achieving our greenhouse gas emissions reduction goals. Silicon Valley Business Journal Structures Awards 2019

The 2019 Silicon Valley Business Journal <u>Structures Awards</u> recognizes the best in local real estate in Santa Clara, Santa Cruz, San Benito, and Monterey counties plus portions of San Mateo and Alameda counties. Staff submitted an application to the 2019 Structures Awards for The Veranda development in the categories of Community Impact and Best Affordable Residential Project. Staff highlighted the strong community support for this development and the groundbreaking use of Santa Clara County Measure A funding to provide six transitional housing units for homeless seniors. Results will be released in August 2019.

The Veranda development was completed in May 2019 and senior residents are currently moving in to all nineteen studio units.

Technology, Information & Communication Commission Hosts Cybersecurity Presentation

On June 25, the City's Technology, Information, & Communication Commission hosted a Cybersecurity Presentation, titled "Protect Yourself from being hacked on the Wild, Wild Internet."

The Presentation was well attended with over 55 people in attendance.

Narayan Makaram, a Cybersecurity Consultant, discussed the importance of protecting digital personas, common ways hackers can steal information, and how to improve Cyber hygiene by practicing best practices.

Prepare Cupertino - Emergency Preparedness Fair

Prepare Cupertino, Cupertino's free 2019 community preparedness fair was this past Saturday, June 22. This fair was a way to inform Cupertino's community members about the importance of getting prepared for an emergency and the simple steps to get started.

The fair included information booths manned by our disaster response partners such as Fire and Sheriff, American Red Cross, Tzu Chi, HOPE with their response comfort dog teams, and many more. Our community members got free hands only CPR training. There were emergency response vehicles in attendance so adults and children alike could learn more about these vehicles and what they do. And each family received a free backpack and giveaways to start their own emergency kit for signing up for AlertSCC, our mass emergency notification system.

Again this year, the fair was combined with Field Day, in which Cupertino's own Amateur Radio Emergency Services team was set up to talk to radios across the country! It was very well attended, and Cupertino now has approximately 550 more community members more prepared for an emergency.









Pride Month Flag Raising Ceremony

On Monday, June 24, Cupertino hosted a flag raising ceremony in honor of Pride Month. Pride Month serves to recognize the impact that lesbian, gay, bisexual, and transgender individuals have had on history locally, nationally, and internationally.

Mayor Steven Scharf, along with representatives from Assemblymember Evan Low's office and the Santa Clara County Office of LGBTQ Affairs, spoke to the crowd and raised the rainbow flag, which will stay up for the remainder of June.

4th of July Fireworks Celebration

Dear Residents:

The Parks and Recreation Department is pleased to announce that the City's annual 4th of July fireworks show will again resume this year. The fireworks will be launched from Hyde Middle School on Thursday, July 4th at 9:30 p.m. For safety reasons, the Hyde Middle School campus will be closed and no spectators will be allowed at this location.

Please review the below information for important notices that may impact your neighborhood. We ask that you consider these viewing locations, street closures, and parking restrictions as you plan your 4th of July celebration. Event logistics may change - please visit the events page over the coming weeks for updates: www.cupertino.org/4thofJuly.

Viewing Locations

The City has identified three recommended viewing locations:

- Creekside Park, 10455 Miller Avenue
- Sedgwick Elementary School, 19200 Phil Lane
- Miller Avenue (between Bollinger Road and Phil Lane) Spectators will be allowed to find a spot on the street after the street has been safely closed at 5:00 p.m.

Parking will be very limited – it is recommended that you walk, bike, or have someone drop you off if you wish to view the fireworks from these locations. We encourage you to bring a picnic, look for signage and direction from staff as to the exact location where fireworks will be viewable, and settle in for the fireworks show. Due to the anticipated crowd size, no pets will be allowed at the viewing sites. This is for the safety of the pets, as well as the safety of others. Limited ADA parking will be available at Sedgwick Elementary School.

Safety & Street Closures

The City is working closely with our law enforcement partners, the Santa Clara Sheriff's Office and Santa Clara County Fire, to ensure a safe event. A dedicated fire engine will be on site at Hyde Middle School to monitor the launch site and any danger from falling embers. The Hyde Middle School campus will be off limits to spectators. Additionally, there will be no pedestrian traffic allowed on Hyde Avenue, Shadygrove Court, Disney Lane, and portions of Shadygrove Drive and Stendhal Lane after 8:00 p.m. Pedestrian traffic will not be allowed in this area to ensure that public safety vehicles have clear access to the streets adjacent to the launch site.

Necessary streets will be **closed to vehicles** anytime between 4:00 p.m. to 1:00 a.m. and **pedestrian traffic** from 8:00 p.m. to 1:00 a.m. Street closures will be staffed by Sheriff's Deputies and City representatives. The closed streets include:

- Miller Avenue (Between Bollinger Road and Phil Lane)
- Atherwood Avenue (Between Candlewood Drive and Miller Avenue)
- Howard Court
- Disney Lane (Between Miller Avenue and Stendhal Lane)
- Phil Lane (Between Miller and S. Tantau) closed only for traffic turning from S. Tantau Avenue
- Stendhal Lane (Between Disney Lane and Phil Lane)
- Shadygrove Drive (between Tantau Avenue and Stendhal Lane)
- Hyde Avenue (Between Bollinger Road and Shadygrove Drive)
- Willowgrove Lane (Between Hyde Avenue and Brookgrove Lane)
- Brookgrove Lane
- Ferngrove Lane

Following the event, Sheriff's Deputies will manage pedestrian and traffic flow in the neighborhood and viewing sites to ensure a smooth trip home.

No Parking/Towing of Vehicles

There will be no parking from 3:00 p.m. to 1:00 a.m. on Miller Avenue (from Bollinger Road to Phil Lane) and Hyde Avenue (from Bollinger Road to Shadygrove Drive). There may be additional areas posted as No Parking as the event details are finalized. Any vehicles parked in posted "No Parking" locations will be towed.

Enjoy the Show!

To ensure the best viewing, please turn off your porch lights or landscape lighting during the fireworks show. For their safety and well-being, bring pets inside. Also, be aware that fireworks could trigger car alarms.
