

## **New Block Leader Training Sessions**

City staff has been working on new ways to increase membership in the Block Leader and Neighborhood Watch programs. As part of this effort, staff has begun a pilot marketing program that identified seven neighborhoods without Block Leader or Neighborhood Watch leaders. These neighborhoods represent each of the City's six reporting zones. Postcards, which outlined the Block Leader program and announced upcoming training sessions, were mailed to nearly 370 resident owners and current occupants. The Block Leader training sessions are set for Wednesday, March 27, at Quinlan Community Hall. ## California Parks and Recreation Society Recognizes 4th of July Event

The annual July 4<sup>th</sup> Celebration was proudly recognized with an Award of Excellence by the California Parks and Recreation Society, District 4, at the organization's annual Awards and Volunteer Recognition Dinner on February 28.

An Award of Excellence recognizes outstanding projects, events, or programs, and serves to recognize and promote agency successes, new creative approaches, and best practices.

The following statement was read at the awards dinner on February 28:

#### July 4th Celebration

The 4<sup>th</sup> of July celebration is a well-loved Cupertino event. What started as a firework show over 25 years ago, has evolved into a jam-packed day of activities. The schedule includes a flag-raising ceremony at our Veteran's Memorial, a pancake breakfast hosted by the Cupertino Optimist Club, a children's parade and carnival, and a concert in the park. Food trucks and free swimming at Blackberry Farm park round out the daytime activities.

In 2015, due to the drought, the City lost its fireworks launch site and the fireworks portion of the event went dark. Cupertino wasn't sure it would ever see fireworks in the City again. In 2017, thanks to some out-of-the-box thinking, committed community partners, and eight weeks of dedicated work, fireworks once again lit the night skies of Cupertino.

The July 4<sup>th</sup> Celebration would not happen without the strong working relationships that the event team has created with the Santa Clara County Sheriff's Office, the Santa Clara County Fire Department, Cupertino Union School District, the City of Cupertino Public Works Department, and the Cupertino Emergency Response Team. With players from every organization, this dedicated team was able to draft and produce a firework show that includes a new firework launch site, new public viewing sites, and a new traffic and parking plan.

## Cupertino GreenBiz Update

Within the past six months, five businesses have been recertified in the Cupertino GreenBiz program, ensuring their commitment to sustainability for another three years. These business include Aloft Cupertino, Bitter+Sweet, Evolution Bike Shop, Rancho Rinconada Recreation Center, and M&S Collision. This month, two new businesses were GreenBiz certified; The Jute Sak, and West Valley Community Services. Green businesses support the community and the environment through a commitment to energy and water conservation, waste management, employee health, and wellness and pollution prevention. ### **Regnart Creek Trail Feasibility Study History**

On August 21, 2018, the Cupertino City Council adopted Resolution No. 18-081 to approve the Regnart Creek Trail Feasibility Study, direct staff to prepare design documents, conduct environmental review for the Regnart Creek Trail, and approve a Budget Adjustment in the amount of \$380,000 in the Capital Improvement Fund for the Regnart Creek Trail Project to prepare design documents and conduct environmental review.

Late that same day, the Santa Clara Valley Water District (Valley Water) delivered a comment letter to the City regarding the Draft Regnart Creek Trail Feasibility Study. Staff drafted a Response to Comment letter for Valley Water on September 14, 2018, and met with Valley Water staff a fourth time on September 17, 2018, to discuss Valley Water's concerns and resolve any outstanding issues. The primary issue related to the construction of a fence or railing along the trail at the top of the creek bank which Valley Water had, at a meeting with City staff on July 11, 2018, indicated would be considered subject to certain conditions and as long as it did not impede Valley Water's ability to maintain the creek. Valley Water's letter from August 21 stated that railing at the top of bank would not be allowed. While no definitive solutions were agreed upon at the September 17 meeting, City and Valley Water staff discussed the issue at length and agreed to cooperate moving forward into the design phase of the project to ensure that both Valley Water's access and maintenance needs, as well as the City's concerns about the safety of trail users, would be addressed to the satisfaction of all stakeholders.

As Valley Water's letter was received the same day as Council adopted the feasibility study, staff was inclined to amend the study to include Valley Water's letter and make other minor administrative cleanup edits. Upon consideration of this, it has been decided to not make any changes to the feasibility study. A feasibility study is not a document to be amended as it represents what is known about a project at a moment in time. If subsequent information is discovered that may change a projects feasibility, then staff would document and disclose this information. At this time, there is no declarative information that makes this project infeasible.

The comments received by Valley Water will be part of the project file, and the City and Valley Water will continue to work together as design progresses. At the Council meeting on May 21, 2019, staff will present to Council a report of the status of project design, as well as an update to

many of the issues in the feasibility study that were inconclusive. The <u>Regnart Creek Trail</u> <u>Feasibility Study webpage</u> has been updated to include the feasibility study as it was presented to Council, without subsequent modifications. Staff will also update the <u>Regnart Creek Trail webpage</u> to more clearly detail project issues and questions near the top of the page. All upcoming community meeting dates will be posted on the webpage and on the City calendar.

Last week, staff distributed door flyers inviting Regnart Creek residents to schedule one on one door visits from March 18<sup>th</sup> through April 12<sup>th</sup>. At this time, 16 of the approximate 80 residents have responded with meetings starting next week. These meetings are occurring in advance of the March 30<sup>th</sup> Community Walkshop meeting where staff and the community will walk the creek from 10am to Noon.

## **Update on All-Inclusive Playground Project**

The City contracted for a feasibility study that was completed in 2018, which investigated options for an all-inclusive playground. An experienced consultant, Verde Design, looked at potential locations, parking, use of park spaces, restrooms, etc. and concluded Jollyman Park would be the best location for our all-inclusive playground. As a result, with approval by the Council, staff applied and was approved for a \$1.448 million grant for the playground from Santa Clara County. At the same time, Council committed to fund \$1.2 million in support as a match. The grant process was very competitive and required a location, concept design, and additional information. The next steps include a public involvement process that includes neighbors who live around the park, bringing a funding agreement forward to Council (awaiting the County to provide the agreement, expected soon) and the purchasing process that will include a request for qualifications to select a fund raising organization. The project would proceed into design and then to construction.

It is important to note that the grant is for a playground installation at Jollyman Park and that placement in another park may jeopardize the existing \$1.448 million award.

One option moving forward is to work with the Magical Bridge organization, which may bring some real advantages to the opportunity to build the playground, and importantly, fundraising. Working with Magical Bridge may result in the need for the playground to be branded as a "Magical Bridge."

Staff will need to complete some important steps to maintain compliance with laws that affect purchasing and contracts, among other items. Ultimately, City Council will confirm the location, vendors who will fundraise, branding opportunities, and the project scope.

The next steps are to proceed with a RFQ and to bring forward the funding agreement from the County, once it is received.

## San Jose Water Company Refund Update and Request to Increase Rates to Cupertino Municipal Customers

In early January, the City was notified by San Jose Water Company (SJWC) that refunds to customers of the water system owned and maintained by SJWC, as well as to the customers of the Cupertino Municipal Water System leased to SJWC would be going to customers in mid-January. An Items of Interest on the issue went out January 11 with a full explanation. In brief, a typical residential customer of the system owned and operated by SJWC will receive a one-time credit of \$6.38 and a typical customer of the Cupertino Municipal Water System leased to SJWC will receive a one-time credit of \$3.77. This past Monday, the City received an email from SJWC that the refunds will begin with bills dated March 11, 2019, and thereafter for a full billing cycle covering all customers (approximately 2 months). Staff is inquiring on why the refunds did not occur during the January billing cycle.

On March 8, 2019, the City received a request from SJWC to authorize a 2019 rate increase to customers of the Cupertino Municipal Water System. This request is consistent to the November 29 action of the California Public Utilities Commission to authorize a 4.55% increase in water rates to customers of the water system owned and operated by SJWC. An Items of Interest regarding the increase of rates to customers of the water system owned and operated by SJWC went out December 14, 2018 with a full explanation. The last rate increase authorized by the City for customers of the Cupertino Municipal Water System occurred in September 2016 (8.6% increase). Due to a variety of issues regarding the operation of the system by SJWC, none of which effect water quality, rate increase requests for 2017 (3.83% increase) and 2018 (4.22%) have not been authorized by the City. Water rate increases due to wholesale water costs increase and similar are not required to be authorized by the City and have occurred. Per the terms of the lease between the City and SJWC for the Cupertino Municipal Water System, the City has 60 days to review this request. Staff will use this time to review the outstanding operational issues and to recommend next steps.

Dear Mr. Borden:

In accordance with the provisions in the Agreement for Lease of Real Property (Water System) between the City of Cupertino (City) and SJWC executed on October 1, 1997, I write to formally seek the City's approval to implement water rate increases to customers of the Water System in 2019.

The California Public Utilities Commission's (CPUC) Final Decision for SJWC's 2018 General Rate Case (GRC) Application granted rate increases for 2019-2021. Per the decision, SJWC filed Advice Letters (AL) 528/528A with the CPUC requesting the implementation of the GRC 2019 rate increase and copies were furnished to the City. AL 528A was approved by the CPUC on December 28, 2018 (attached) with new rates effective January 1, 2019.

We continue to appreciate the opportunity to provide safe, high quality and reliable water service to the City's residents and look forward to continuing our partnership.
