# Lehigh Southwest Cement Company (Lehigh) Issues Press Release for Major Reclamation Plan Amendment

On Wednesday, May 22 Lehigh issued a press release indicating the submission of a major reclamation plan amendment (amendment) to the County. The City has not received a copy of the amendment to review. The press release is attached for reference. Two items of information stated within the press release include:

"In addition to updating mine and reclamation planning, the reclamation plan incorporates a new mining area – within Lehigh's vested rights area, as determined and approved by the Santa Clara County Board of Supervisors in 2012 – and the most current regulatory requirements. It also addresses site-specific water quality considerations. The plan provides detailed performance standards for restoring areas at the completion of mining and addresses the specific requirements of the state's surface mining laws" and:

"The updated plan provides for reclamation of all existing and planned mine areas, will improve the appearance of the reclaimed site by increasing vegetative cover, and will provide improved stability of the Permanente Ridgeline. The plan also allows Lehigh to accept excess soil produced from regional construction as an integral part of the improved reclamation for the quarry".

The City responded to the press release with the following statement:

"The City is committed to reviewing the application and providing comments to the County that best represent the concerns of our community and protection of the environment. To facilitate this process, the City will host a community meeting at a date to be determined to receive more information from the County and Lehigh, as well as hearing from our residents." (Please see the Mercury News article)

As reference, on March 25 Lehigh submitted a "Revised Utility Road Reclamation Plan Amendment" to the County. Details of this were provided in Items of Interest dated March 29, 2019. The status of this revised plan amendment is not currently known as it may be withdrawn and incorporated with the May 22 amendment.

Staff is following this issue. The City webpage for Lehigh will be updated with the May 22 Lehigh press release and the amendment when it becomes available.

#### 2019 Homeless Census

On May 16, 2019, the County of Santa Clara and the City of San Jose released preliminary results of the 2019 Homeless Census. According to the new data, the regional homeless population has grown significantly. For every person who exits homelessness, three new people seek assistance.

The County of Santa Clara's overall homeless count was 9,706, which is an increase of 2,312 over 2017. The complete Point-in-Time Count report and data for the full 15 cities in Santa Clara County will be available in July. Cupertino specific data will be made available at that time.

# McClellan Road Separated Bikeways-Imperial Avenue to Stelling Road

Construction resumed on this project beginning May 20 and includes shifting the northern sidewalk north to create room for the bike improvements. Once that is done, raised bicycle curbs 18 inches wide will be installed to define and separate the bike lane from the rest of the road. Delineators will be added to increase visibility of the bicycle curbs. The contractor for the work is Redgwick Construction.

The photo below is a simulation of how the improvements will look:



Construction start time is 9 a.m. and will be expanded to 7 a.m. on June 10, after schools are out of session. The project is anticipated to be completed prior to school starting in August. This initial phase of the project has been coordinated with the local schools, the Fremont Union School District, and the Cupertino Union School District. The attached information update was mailed to approximately 550 residents within the project area.

The McClellan Road Separated Bikeway Project is a multi-phase project to install separated bike lanes on McClellan Road between Torre Avenue and Byrne Avenue.



Vehicle, bicycle, and pedestrian traffic will be affected by this project. Staff will be monitoring all phases of construction. If there are any issues or safety concerns, they can be reported to the Project Manager, John Raaymakers at (408) 777-3354 or johnr@cupertino.org.

#### 17th Annual Appreciation Event Honors Block Leaders' Shining Work

Nearly 80 Block Leaders participated in the Block Leader Appreciation event last Wednesday, May 15. Mayor Steven Scharf thanked the volunteer leaders for their important work in the neighborhoods, and was joined by Councilmembers Darcy Paul and Rod Sinks. Several Block Leaders were recognized for one, five, 10, and 15 years of service. Participants took part in a "Speed Date" activity of several rounds to share how neighbors connect and their neighborhood plans. They also contributed to the wall of "Shining Work".







#### **National River Cleanup Day 2019**

On Saturday, May 19, the City was a participant in National River Cleanup Day by hosting 52 volunteers for cleanup of a two mile stretch of Calabazas Creek adjacent to Creekside Park (Stevens Creek Boulevard to Bollinger Road). A total of 217 lbs of trash, 111 lbs of scrap metal, and 6 lbs of recyclable bottles and cans were pulled from the creek during the three hours of the event, including a heavily rusted metal car wheel. These events are a fun opportunity for community members of all ages to walk the creek and engage with City staff about the different ways the trash accumulates, the sources, what impacts litter has on our local ecosystems, our community and the Bay region, and what solutions exist to resolve the problem. On Saturday, September 21, another cleanup event will be held in the same location to celebrate California Coastal Cleanup Day.



#### City Hosts Second in Google Workshop Series for Small Businesses

On May 22 the City, in conjunction with the Cupertino Chamber of Commerce, Grow With Google, and Pacific Workplaces, hosted the second in a series of Google-focused free small business workshops. # Lehigh Southwest Submits Application to Open New Mining Area and Improve its Reclamation Plan at the Santa Clara County Facility

Cupertino, Calif. (May 22, 2019) – Lehigh Southwest Cement Company (Lehigh) today formally submitted to Santa Clara County its application seeking approval of an improved reclamation plan for the Permanente Quarry. Throughout its history, Lehigh's Permanente Quarry and its adjacent cement facility have provided cement and construction aggregate materials used in concrete and asphalt to build thousands of homes, buildings, roads, and important public infrastructure throughout Northern California.

Located in the Santa Clara County hills west of Cupertino, the quarry has been in operation since 1903. The quarry is a major source of limestone used for making cement used throughout Northern California, providing roughly 50 percent of the cement used in the Bay Area, and about 80 percent of the cement used in the communities of Santa Clara County. With continued economic growth in the Bay Area, and an increased need to repair and rebuild aging infrastructure, market demand for locally produced cement remains strong. It is one of only seven active mines in California with limestone deposits suitable for cement production, and the only one in the Bay Area.

More than 180 employees – many of them union members – work at the quarry and cement plant. Lehigh's operations generate hundreds of additional jobs in the region related to providing goods and services for Lehigh's operations and its workers.

"As one of the only sources of locally produced cement in Northern California and the only source in the Bay Area, it is imperative to our economy and our environment that we continue to operate and produce material from this facility to serve the region's construction and infrastructure needs in a timely manner," said Erika Guerra, Environmental and Land Management Director for Lehigh. "The concept is simple, just as 'farm-to-table' makes environmental and economic sense, so too does 'quarry-to-construction site'. A local source of construction materials and cement reduces the environmental footprint of regional construction, and provides local jobs and tax revenues. It's all about producing and consuming locally, and the associated community and regional environmental benefits."

Lehigh's proposal is a voluntary and comprehensive update to its reclamation plan approved by the County in 2012. In addition to updating mine and reclamation planning, the reclamation plan incorporates a new mining area – within Lehigh's vested rights area, as determined and approved by the Santa Clara County Board of Supervisors in 2012 – and the most current regulatory requirements. It also addresses site-specific water quality considerations. The plan provides detailed performance standards for restoring areas at the completion of mining and addresses the specific requirements of the state's surface mining laws.

The updated plan provides for reclamation of all existing and planned mine areas, will improve the appearance of the reclaimed site by increasing vegetative cover, and will provide improved stability of the Permanente Ridgeline. The plan also allows Lehigh to accept excess soil produced from regional construction as an integral part of the improved reclamation for the quarry. This opportunity benefits ultimate site reclamation while providing for improved water quality management at the site and, importantly, an option for the beneficial reuse of surplus construction soil generated in the region.

Without use at Permanente Quarry, much of the surplus construction soil generated in the region would need to be transported farther distances. Use of this soil at Permanente Quarry will decrease vehicle miles traveled – encouraged by Santa Clara County's General Plan and a primary goal of recent state environmental law amendments – and will decrease transportation costs and transportation-related air pollutant and greenhouse gas emissions.

"Updating the reclamation plan will allow us to keep providing a local supply of a vital construction material while also improving environmental, geotechnical, and aesthetic conditions at the site," Guerra said. "We believe this plan will benefit our local economy and provide environmental improvements while meeting the region's construction needs."

Throughout this process, Lehigh will continue to meet the extensive requirements of California's regulatory system. Lehigh will continue to engage the local community and stakeholders that will benefit from this improved reclamation plan.

The application will be processed by the County's Department of Planning and Development as a Major Reclamation Plan Amendment according to the County requirements for implementing the California Surface Mining and Reclamation Act of 1975. The County's review process will require that the County prepare an Environmental Impact Report to comply with the California Environmental Quality Act (CEQA). The CEQA process includes opportunities for input from the community and regulatory agencies. Lehigh is confident that the merits of its proposal and the comprehensive plans and environmental considerations incorporated in the development of the updated reclamation plan will serve to expedite the County review and approval, while also gaining community support.

# County of Santa Clara, City of San José Release Results of 2019 Homeless Census

Regional homeless population has grown significantly as nearly three new people seek assistance for each person who exits homelessness; signs of progress in housing families and veterans

**Santa Clara County, Calif.** – The County of Santa Clara and City of San José today announced preliminary results of the biennial homeless census covering the County's 15 cities and unincorporated areas. The count, conducted over two days in January 2019, found the number of homeless adults increased significantly over the past two years, resulting in an increase in the region's overall homeless population.

Together, the County and City have housed approximately 4,000 formerly homeless families and individuals since 2017. Despite these efforts, the number of newly homeless residents continues to outpace the capacity of County and City systems to place people in stable housing. Nearly three new people are seeking assistance from the County for each person who exits homelessness.

"The reasons for homelessness are many and varied," said Joe Simitian, President of the Santa Clara County Board of Supervisors. "The high cost and shortage of housing are making a bad problem worse. Combining our efforts to prevent homelessness and create supportive housing with 2016 Measure A – Affordable Housing Bond – funds will continue to be an essential strategy in addressing homelessness. So far, the County has committed \$234 million of Measure A funds toward 19 housing developments that will collectively add 1,437 apartments for the most vulnerable in our community."

The County of Santa Clara's overall homeless count was 9,706, which is an increase of 2,312 over 2017. In San José, the overall homeless count was 6,172, which is an increase of 1,822 over 2017.

"Despite our collective efforts to house more than 6,900 homeless neighbors in the last three years, for every person we bring in from the cold, the economy pushes three more out the door," said Mayor Sam Liccardo.

We must double down on homelessness prevention and, in turn, alleviate the human misery and greater public cost following an eviction notice. It's also time to end the reign of the NIMBY in Silicon Valley. We all have a shared responsibility to address this crisis — every city and every neighborhood. That means we must house homeless neighbors here, not the proverbial 'somewhere else'."

In Santa Clara County, the 2019 census found the number of homeless family members was 921, down from 1075 in 2017. The number of homeless veterans was 653, down slightly from 660 in 2017.

The census found the number of homeless family members in San José was 313, down from 340 in 2017. The number of homeless veterans was 476, up slightly from 468 in 2017.

To address the rise of homelessness, the County and City are focused on building deeply affordable housing. The County has prioritized development of housing for residents experiencing homelessness and households making less than 30 percent of Area Median Income. The San José City Council recently approved allocating 45 percent of the City's investments in permanent affordable housing for extremely-low-income residents.

The 2019 census found the numbers also increased for chronically homeless and the unsheltered population.

- Countywide, the number of chronically homeless was 2,470, an increase of 373 over 2017. The percentage of homeless county residents who were unsheltered was 82 percent, up from 74 percent in 2017. And the number of unaccompanied youth and young adults was 1,876. While this figure was down from 2017, the decline was due in part to a change in methodology for counting young people.
- In San José, the number of people considered chronically homeless was 1,579, an increase of 374 over 2017. The percentage of homeless residents who were unsheltered was 83 percent, up from 74 percent in 2017. And the number of unaccompanied youth and young adults was 1,391. This was down from 2017. However, as with the County, the decline was due to a change in methodology.

"Now is the time to redouble our efforts to solve this crisis," said Jennifer Loving, Chief Executive Officer of Destination: Home. "The solutions are right here in front of us - we just need to mobilize the collective will and resources to scale our proven strategies and meet the enormous need in our community. Bottom line: homelessness is solvable."

The McClellan Road Separated Bikeways-Phase 1a, between Stelling Road and Imperial Avenue, is the first phase of a larger project which will construct a physical separation between motor vehicles and bicyclists.

Once all phases are complete, there will be separated bike lanes on McClellan Road from Torre Avenue to Byrne Avenue.

- The construction start date is May 20, 2019. The anticipated completion date is August 8.
- From May 20 to June 7, the contractor's working hours are 9 am to 6 pm.
- Starting on June 10, construction hours are 7 am to 6 pm.
