Cupertino to Host Poverty Simulation


The City of Cupertino, West Valley Community Services, and Step Up Silicon Valley are hosting a Poverty Simulation on Saturday, November 2 from 10 a.m. to noon at Cupertino Community Hall. More than 30% of Santa Clara County residents cannot afford basic necessities each month without financial assistance, according to recent reports.

The Poverty Simulation immerses participants in the reality of a Silicon Valley that grows in disparity as much as prosperity. During the simulation, participants work to overcome barriers to social services, live off insufficient income, and encounter unforeseen economic obstacles along the way.

Nextdoor Unveils "Kindness Reminder" Function

Social media platform Nextdoor has rolled out a "Kindness Reminder," a new feature meant to encourage positivity across the platform. If a member replies to a neighbor's post with a potentially offensive or hurtful comment, Kindness Reminder will be prompted before the comment goes live. The member is then given the chance to reference Nextdoor's Community Guidelines, reconsider and edit their reply, or ultimately refrain from posting. In early tests in the US, 1 in 5 people who saw Kindness Reminder hit "edit" on their comment, resulting in 20% fewer negative comments. To read more, please click <u>here</u>.

Second Annual Bobateeno

The City held its second Bobateeno this past Saturday, September 21 at the Cupertino Civic Center. This was the second collaboration between the Teen Commission, the Youth Activity Board, and the Parks and Recreation Department. Over 600 teens enjoyed boba while connecting with valuable wellness and school resources, such as Innovation Launchpad, MVHS Bring Change 2 Mind, Code This, MVHS GSA, the 'You Are' Art Collective, the Cupertino Sports Center, and the Safe Routes to School program. An additional goal of this year's event was to connect attendees with the value of outdoor recreation and socialization. In order to meet this objective, City staff organized mobile recreation activities, which included ping-pong, giant Jenga, and Connect 4. The newest additions of volleyball, badminton, and slackline were well-received and saw continuous use throughout the event. This is the latest effort in helping supplement young adult development by showing teens the intrinsic value of an active lifestyle with firsthand experience.



Over 100 in Attendance for Zero Waste Home Event with Speaker Bea Johnson

On September 24 at Community Hall, the Sustainability Commission, Sustainability Division, and Environmental Programs Division co-hosted the event, "Zero Waste Home with Bea Johnson." Over 100 Cupertino residents and other members of the public listened to Bea Johnson's inspiring presentation on the benefits of waste-free living, and practical advice in how

to adopt this lifestyle. Widely featured in the media and dubbed "The Mother of the Zero Waste Lifestyle Movement" by CNN, Bea is a leading spokesperson for this lifestyle. With speeches in 65+ countries on 6 continents, she has spoken at Google, Starbucks, the United Nations, and completed 19 international tours.

As part of the event, staff held a raffle for signed copies of Bea's book, *Zero Waste Home*. Commissioner Vignesh Swaminathan, Sustainability Manager Andre Duurvoort, and recently retired Environmental Programs Manager Cheri Donnelley shared insights on Zero Waste and recycling in Cupertino. Staff used the City's "Zero Waste Kit" with reusable cups and served finger foods to minimize waste at the event.

A Zero Waste lifestyle offers many personal and financial benefits for our households, but also is an important way to address challenges to our society's waste and recycling systems. <u>The United</u> <u>States Conference of Mayors</u> defines Zero Waste as a set of principles to reduce and eliminate materials going to landfill.

Paving Maintenance Phase 2

The second phase of the City's annual pavement maintenance project will begin Friday, September 27 and is scheduled to be completed by October 31. This project includes 23 street segments, which will receive a crack seal treatment to close minor cracking. The streets are receiving preventative maintenance treatments that extend the life of the pavement instead of requiring a more expensive treatment like asphalt overlay.
