City Releasing Daily Report Regarding COVID-19 (Coronavirus)

The City of Cupertino continues to monitor the effects of the COVID-19 (coronavirus) as the safety of our residents remains our highest priority. In an effort to ensure that our residents, businesses, and visitors are up to date, the City is releasing a daily report regarding COVID-19. A report will be posted each weekday at 5:00 p.m. The report features news about the cancellation/postponement of events, helpful online City services, and information on City operations. City Actions and Services

The City of Cupertino is responding to the statewide Stay-at-Home order and Santa Clara County Public Health Department's Shelter-in-Place order to help slow the spread of COVID-19 in the local community. During this time, the City is working hard to continue providing essential services. The following are updates on the City's actions and services:

- All City facilities remain closed until further notice.

City Offering Virtual Building Inspections of Essential Projects

The City of Cupertino is committed to keeping our citizens and its staff safe in times of crisis. To keep our building inspection process moving, Cupertino is utilizing standard video conferencing software to provide virtual inspections for essential activities while building inspectors are complying with the County's Shelter-in-Place order. Also, the Geographic Information System (GIS) Division and the Building Division worked to develop a longer-term solution that allows applicants to submit building inspection videos in lieu of a physical inspection. Applicants upload their submission through an online form, the videos are stored into a que, and inspectors review the video remotely. While the form was developed in response to the COVID-19 pandemic, the Building Division expects this new video inspection review process to remain a part of Cupertino's inspection process for limited scopes of work. Currently, the Building Division offers six minor building permits that can be applied for and issued entirely online. These permits consist of water heater and furnace replacements, re-roofs, siding replacement, whole house re-pipes, and electrical panel upgrades. The Building Division plans to integrate this process with Accela to enables citizens/contractors to upload the videos at their convenience for these minor projects. It is anticipated the benefit of this new service will increase the number of inspections per day for one field inspector while in turn it allows for additional time for the other building inspectors to focus on the more complex projects.

Essential Cupertino Business Remain Open

Some Cupertino businesses, including grocery stores, supermarkets, coffee shops, restaurants and more, continue to operate through the statewide Stay-at-Home order and County of Santa Clara's Shelter-in-Place order. The businesses that remain open have been identified as "essential businesses" per the County's definition. Via-Cupertino Continues to Operate Using Preventative Measures

In order to encourage social distancing, while continuing to provide transportation services for those who rely on it, Via-Cupertino will now operate as a private service. This means that only one passenger will be allowed per van. No additional riders will be permitted inside the vehicle aside from the passenger and the driver. The fares will remain the same and the "plus one" additional rider features will be temporarily disabled. This new policy is effective immediately and will remain until further notice. City of Cupertino Accepting Supplies for Local Kaiser Hospital

The City of Cupertino is accepting needed supplies for the local Kaiser hospital to use by their medical staffs. They include unopen and packaged: non-vented goggles, face shields, hand sanitizer, masks (N95, surgical, and isolation masks), isolation and surgical gowns, and sanitizing wipes. Donations can be made in bins in front of Cupertino City Hall, 10300 Torre Avenue, or the Cupertino Library, 10800 Torre Avenue.

Seeking Urgent Relief and Community Support

Changes to Non-Essential Trash and Recycling Services in Cupertino

The following services are impacted during the Shelter-in-Place order in Santa Clara County:

- There will be no appointments for on-call collections or bulky item pickups.
- Residential customers are allowed to place one extra bag of trash out for collection next to
 the garbage cart as needed without a bag tag. Please ensure the bag is tied tightly shut.
 This service is to accommodate extra trash generated from being home during Shelter in

- Place, and for those who need extra service but cannot get a larger cart right now. Please do not set out bulky items or other trash produced from home clean-up projects.
- Recology cannot accommodate any requests for downsizing or upsizing residential trash
 carts at this time, unless it is a safety issue. Contact Recology is you require an exchange
 due to a safety issue, or if your cart or bin is missing and you require a new one.
- Save room in your trash cart by putting all food-soiled paper and food scraps in the compost cart. Break down all cardboard and paper boxes, and bundle and tie any extra cardboard for collection. Visit Recology's Your Three Carts page for more information.
- The Centers for Disease Control has determined that the COVID-19 virus is not a Category A infectious substance; therefore, solid waste from households that are, or are suspected to be, contaminated with the virus can be managed as it would be for the flu. In an abundance of caution, you should ensure waste bags are tightly closed and curbside containers are not overfilled, to ensure the lids can close completely. Please notify Recology if you know or suspect your waste is contaminated with the COVID-19 virus.
- Commercial customers who have closed their businesses during the Shelter in Place order are eligible to suspend their trash service. Commercial customers who have significantly reduced their activities may request to reduce their level of service.
