NASA Speaker Series

NASA has landed in Cupertino for a year-long speaker series aimed at educating, motivating, and entertaining the community. The first event will be held on January 22 from 4:00 p.m. to 6:00 p.m. at Community Hall, 10350 Torre Avenue.

The first speaker will be Jerry Davis, former Global NASA chief Information Security Officer for Lam Research, whose talk is titled "Life as an Existential Threat." He will discuss how he overcame the existential threat of life—including extreme poverty, hunger, homelessness, and racism—to become one of the most inspirational security executives today.

Bicycle Pedestrian Commission Unexpected Vacancy: Alternate Fills

Bicycle Pedestrian Commissioner Pete Heller resigned from the Commission effective November 30, 2019. During the January 2019 Commission interviews, Council appointed Technology, Information & Communication Commission incumbent Ilango Ganga as the Bike Ped Commission's 1st alternate, and he will fill the vacancy as per Council resolution. Ilango has resigned from the TIC Commission and will attend the regularly scheduled Bike Ped Commission meeting in February. The resignation letter from Pete Heller is attached. In January 2019, Council also appointed Mukesh Garg as the TICC's 1st alternate, and he will fill Ilango Ganga's open seat. Mukesh will attend the special meeting in January.

Environmental Education Center

More than 3,400 visitors stopped by the Environmental Education Center at McClellan Ranch Preserve during free Open House hours on Saturdays and Sundays during 2019. Visitors met and learned about resident reptiles, amphibians, insects, spiders, and small mammals from knowledgeable part-time staff.

Baer Blacksmith Shop Demonstration

Approximately 80 visitors attended the last blacksmithing demonstration on Sunday, December 29, 2019. The next one is scheduled for Sunday, January 26, 2020 from 11:00 a.m. to 3:00 p.m. *This event will be canceled if a Spare the Air advisory is issued.*



Mushroom Identification Course

Christian Schwarz, mycologist and co-author of *Mushrooms of the Redwood Coast*, will be teaching a 4-week Introductory Mushroom Identification course on Wednesday evenings at the Environmental Education Center beginning January 8. This class will also include two 3-hour Saturday field trips.



Lawson Teen Center

The Cupertino Parks and Recreation Department launched a satellite Teen Center location at Lawson Middle School on January 6, 2020. For five days a week from January 6 – May 20, 2020, Parks and Recreation staff will be operating a specialized version of the Cupertino Teen Center out of Lawson and engaging middle school students through mentorship and supporting their social development. Registered students will be able to easily walk to the Lawson Teen Center right after being dismissed from school. This structured afterschool program will include hourly periods where students will complete homework and participate in new daily activities ranging from educationally enriching to recreational. Daily themes include STEM Mondays, Craft Tuesdays, Sports Wednesdays, Enriching Thursdays, and Fun Fridays. The opening of the Lawson Teen Center is the latest collaboration between the City of Cupertino and the Cupertino Union School District.
