<u>News and Updates Regarding COVID-19</u> City Communications Regarding COVID-19 (Coronavirus)

The City of Cupertino continues to monitor the effects of the coronavirus (COVID-19) as the safety of our residents remains our highest priority. All City facilities remain closed until further notice. While City Hall is closed to the public, the City continues to provide essential services online at <u>cupertino.org</u> and by phone at (408) 777-3200. These essential services include responding to 311 requests and maintaining the City's infrastructure, among others. For detailed and up-to-date information regarding COVID-19, visit <u>U.S. Centers for Disease Control and Prevention (CDC)</u> and <u>Santa Clara County Public Health Department</u>.

County Updates Shelter-in-Place Order

The City of Cupertino has received numerous inquiries regarding the current <u>Shelter-in-Place</u> <u>Order</u> issued by Santa Clara County. The current Order has no end date and will remain in effect until the Health Officer rescinds it. An amended Order went into effect on Friday, June 5, allowing multiple sectors and activities to resume.

The updated Order:

- Expands previously permitted business activity to include outdoor dining at restaurants and in-store shopping at retail locations.
- Permits all children to take part in childcare, summer camps, summer school, or other educational and recreational programs, so long as groups are limited to 12 or fewer.
- Allows outdoor gatherings of up to 25 people for religious services and cultural ceremonies.
- Allows outdoor recreational activities that do not involve physical contact, such as swimming, to resume.
- Permits car-based gatherings, including drive-in theaters.

Outdoor Recreational and Athletic Activities Update

Non-contact recreational and athletic activities with members of other households may occur subject to the following limitations:

- No more than two households may engage in these recreational and athletic activities together at any one time.
- No equipment (except balls, frisbees, or other thrown objects) may be shared between households or living units.
- All recreational and athletic activities with members of another household or living must occur entirely outdoors.
- Members of separate households must remain at least six feet apart at all times.
- Face coverings must be worn when recreating with members of another household, except when exercising or by people who are exempted from the face covering requirement pursuant to the Health Officer's Critical Guidance on Face Coverings. theaters.

All Park Restrooms to Reopen

The City of Cupertino will reopen all park bathrooms by Wednesday, June 17. Restrooms at some sites, such as Blackberry Farm and McClellan Ranch Preserve, will reopen by Monday, June 15.

Rules include:

- Follow social distancing protocols
- Only one person or members of the same household may occupy the restroom at one time
- Wash your hands with soap and water for at least 20 seconds

Cupertino Promoting Outdoor and Expanded Area Dining

The City of Cupertino is promoting outdoor and expanded area dining with a Special Temporary Outdoor Dining Permit. There is no application fee or processing cost. This action coincides with Santa Clara County's revised Shelter-in-Place Order, which became effective on Friday, June 5. Businesses can download the permit <u>here</u>.

SVCE Offers \$10 Million for Customer and Community Relief

Silicon Valley Clean Energy (SVCE) is committing \$10 million to programs providing relief to customers and communities. Some customers of <u>SVCE</u>, which include Cupertino residents and businesses, will receive direct financial assistance on their upcoming electricity bills. Residents on the <u>CARE/FERA</u> electric rates will receive a total of \$100 in bill credits automatically. Small businesses can apply for a \$250 credit on their electric bill. Notice to qualifying businesses will arrive by mail with instructions on how to apply for the credit.

Calling all trades and contractors! SVCE is also offering a \$500 financial relief stipend for participants to complete a training program regarding all-electric technologies. Building owners, architects, and developers will be asking about installing all-electric technologies in your next construction project. Get a step up on how to design, install, and maintain modern building systems through SVCE's free online training courses. Training will cover products such as heat pump HVAC systems, heat pump water heaters, electric induction stoves, and all the wires needed to support increased electric loads. The stipend will be provided for participating contractors upon completion of the training program. Complete the <u>interest form</u> to receive updates and more information.

In addition, SVCE is investing \$5 million in planning and infrastructure development grants for local jurisdictions to reduce the economic and public health impacts from power outages.

Waste Sorting Webinar Available Online

The City's Environmental Programs Division hosted a free waste sorting webinar on Wednesday, May 27 in collaboration with Recology, the City's waste hauler. The webinar provided guidance to Cupertino residents on how to better manage their waste during the current Shelter-in-Place Order. Participants learned about general waste sorting as well as hearing about the impacts of COVID-19 on the waste industry. Nearly 140 people registered for the webinar and 74 individuals attended the webinar. Participants engaged in a live Q&A with staff from both the City and Recology, posing over 80 questions and comments during the webinar. Since then, the YouTube video of the webinar has been viewed 50 times. A post-webinar email was sent to registrants that included a compilation of the Q&A's, waste sorting guide, link to the recorded webinar, and other resources. Sanitation Services for Homeless Encampments


The City has partnered with Recology Cupertino to offer trash removal at both homeless encampments on Wolfe Road. Bins were placed at the sites on Thursday, June 4. Pickups will be on Mondays and Fridays. The City is also looking into adding washing stations and portable toilets at the sites. This is being done to ensure that there are sanitary conditions at both sites for the health and well-being of the encampments' members and those living nearby.

Homeless encampments cannot be broken up during the pandemic unless individual housing units are identified, according to guidelines by the Centers for Disease Control (CDC). The CDC states: "Clearing encampments can cause people to disperse throughout the community and break connections with service providers. This increases the potential for infectious disease spread." Due to this guidance, the County of Santa Clara has exempted the homeless in its Shelter-in-Place Order.

General City News and Updates City Unveils Digital Signatures for Contract Signing

The City of Cupertino's Applications Division of the IT Department implemented Adobe Sign digital signatures for the contract signing on final executed city contracts. All City contracts require signatures from the City Attorney, department head or managers, City Clerk, and the contractor. As most of the City's staff members are working from home due to the Shelter-in-Place order, it presented a challenge to get wet signatures from all stakeholders.



IT-Applications resolved this challenge by collaborating with the City Attorney's Office and crafting a digital signature process for any citywide contract signing. IT staff configured the Adobe Sign application with custom workflows and templates, enabling department contract administrators to process contracts and procure digital signatures from the contractors, City Attorney, and City staff. Utilizing digital signatures on citywide contracts streamlines the process for the City Attorney's Office and other City staff to manage the contract signing process.

Cupertino Junipero Serra Trail Project Receives Approval for Funding

On April 20, the City's Public Works Department submitted two Cupertino trail projects—the Junipero Serra Trail East and Junipero Serra Trail Central segments—for the 2016 Measure B Bicycle and Pedestrian Capital Projects Competitive Grant program. The VTA Board of Directors, following their staff recommendations based on its scoring committee results, voted on June 4 to approve a funding allocation of \$6.12 million for these two projects. The money will fund construction of the east segment as well as the design and construction of the central segment. This funding will supplement the \$1.8 million donated by Apple for the design of the trail.

The Junipero Serra Trail comprises a generally east-west trail segment that will deliver a significant portion of "The Loop," a bicycle route that comprises several high-priority projects, encircles Cupertino, and will link a number of popular destinations in the City. The east and central segments will parallel the Junipero Serra channel south of Interstate 280 between De Anza Boulevard and Calabazas Creek, and along Calabazas Creek from Interstate 280 to Vallco

Parkway. This project was ranked a Tier 1 high-priority project in the Cupertino Bicycle Transportation Plan and Pedestrian Transportation Plan.
