## **City Hires Joanne Magrini as New Director of Parks and Recreation**

The City of Cupertino is pleased to announce the hiring of Joanne Magrini as the new Director of Parks and Recreation. She will start on June 1, 2020.

“We are thrilled to have Joanne join us in Cupertino,” City Manager Deborah L. Feng said. “Her experience and positive energy will be a wonderful addition to our Parks and Recreation Department.”



Magrini joins Cupertino after serving in a similar role for the City of San Bruno’s Community Services Department. In San Bruno, Magrini oversaw the Department’s five divisions, including Administration and Recreation Services, Parks Maintenance, Senior Services, San Bruno Public Library, and Buildings and Facilities. Her responsibilities included:

- Community programs and recreation activities
- Special events and event space
- Senior and library services
- Maintenance of City parks, City street trees, street medians, open space, and facilities

“I am extremely excited to join this incredible team and help carry on the excellent work being done to create a positive, healthy, connected community in Cupertino,” Magrini said.

Magrini previously served in the University of San Francisco’s (USF) Recreational Sports Department for over 20 years. She oversaw USF’s building operations, which involved hiring and training staff, financial accounting operations, and program management.

Magrini has a Master of Arts Degree in Sports and Fitness Management from USF, and a Bachelor of Arts in Communications with a minor in Sports Management from the University of California, Santa Barbara.

## City Compost Site to Reopen

The City of Cupertino will be reopening its compost site to residents for free pickup on Friday, May 29 at 8:00 a.m. The compost site will be open on Fridays and Saturdays from 8:00 a.m. to noon from May 29 to mid-November. The site is located at 12100 Stevens Canyon Road across from the Stevens Creek Reservoir dam parking lot.

New health protocols have been put in place and include:

- Face coverings and social distancing are required
- Shovels will not be provided
- There is no public access to the portable restroom at the site

Reminder: There are no containers or bags offered at the site. Visitors need to bring their own containers or bags to carry out compost.

The City understands that residents are excited to have access to this service again after such a late start. Residents are urged to be patient as there may be a long waiting period first thing in the morning. The City encourages residents to arrive later in the morning. There is plenty of compost at the site, so it is not anticipated to run out.

Attendants at the site will be directing traffic and visitors will need to follow instructions so that vehicles can get in and out of the compost loading area safely.

## Fremont Union High School District Graduation Car Parades

On Thursday, June 4, the Fremont Union High School District will be having car parades for the 2020 graduates of Cupertino High School, Homestead High School, and Monta Vista High School, as well as other high schools in the surrounding communities. The car parades will begin approximately two hours prior to the virtual graduations, which will allow students to return home for the virtual ceremonies. The graduation times are as follows:

The Santa Clara County Sheriff's Department will be controlling traffic during these events and residents should expect travel delays during the car parades. The City will be placing changeable message boards along McClellan Road, Bubb Road, and Finch Avenue to provide additional notifications to nearby residents and motorists.

## **Via-Cupertino Community Shuttle Update**

Via-Cupertino continues to operate for essential trips during this Shelter-in-Place Order. Hours of operation on weekdays remain the same, Monday through Friday from 6:00 a.m. to 8:00 p.m. Saturday service is being temporarily discontinued. Fares remain the same at \$3.50 per trip with the “plus one” additional rider feature being temporarily disabled.

Only one passenger is allowed per van (up to three from the same household) to encourage social distancing. Riders are required to wear face coverings in the van, and a limited supply of masks are available onboard upon request. Plexiglass dividers will soon be installed between the driver and the rest of the van to create the safest riding environment possible. The vans are sanitized regularly by Via.

## **Updates to Blackberry Farm Golf Course**

The City of Cupertino reopened the Blackberry Farm Golf Course on Monday, May 11. Changes will be made effective on Thursday, May 21, which include:

- Foursomes will be allowed
- The last tee time of the day will be 6:30 p.m.
- The driving range is open
- The pro shop is closed to the public, but merchandise may be purchased

## **Cupertino Tennis Courts Usage Update**

Tennis courts in the City were reopened, and now have updated usage regulations.

- Singles play: Players may play against a member of another household following social distancing protocols. Touching of tennis balls is restricted to a player and balls must be distinguishable, such as different brands or different numbers. As an alternative, labeling them with a permanent marker is acceptable.
- Doubles play: Now allowed at the Cupertino Sports Center. Partners must be from the same household but may play against partners of another household following social distancing protocols. Touching of tennis balls is restricted to partners and balls must be distinguishable, such as different brands or different numbers. As an alternative, labeling them with a permanent marker is acceptable.

## **Contractors Can Now Submit Bids Electronically**

The City of Cupertino has gone live with an electronic bidding module, which allows contractors to submit their bids and supporting documents electronically. The City has already successfully utilized this application on several projects. Before this application, contractors had to physically visit City Hall to submit hard copies of their sealed bids, as well as to hear the bid results during bid opening dates. This process was transparent but required contractors to be physically present at City Hall. With City Hall closed to the public under the current Shelter-in-Place Order, the need to provide an electronic bidding functionality for contractors was evident.

Contractors can now submit their bids and supporting documents electronically to the City. After the City verifies the authenticity of the submitted bids, the application restricts opening the bids


and related documents until after the specified bid opening date and time scheduled for that bid. The City provides an electric confirmation to the contractor showing the date and time their submission was received by the City as soon as the contractor submits a bid.

This module was developed in-house by the City's Applications and Capital Improvement Projects (CIP) divisions. The e-Bidding module expands the capabilities of an existing application at no cost, versus off-the-shelf applications that require costly customizations in addition to yearly subscription charges.
