## **General City News and Updates**

### **State Pulls Emergency Brake to Curb COVID-19 Transmission**

Citing concerns regarding a sudden rise in COVID-19 cases and hospitalizations, the State of California announced on Monday, November 16, that Santa Clara County is moving directly into the most restrictive Purple Tier of the [Blueprint for a Safer Economy](#). This change took effect on Tuesday, November 17 at 12:01 a.m. Under the State's Blueprint, the Purple Tier indicates that the risk of community transmission in the County is widespread.

As COVID-19 cases sharply increase across the country and California, Governor Gavin Newsom and state public health officials announced immediate actions to slow the spread of the virus. The state pulled an emergency brake in the Blueprint for a Safer Economy, putting 94.1% of California's population in the most restrictive tier. The state will reassess data continuously and move more counties back if necessary. California is also strengthening its [face covering guidance](#) to require individuals to wear a mask whenever outside their home, with limited exceptions.

### **Purple Tier Prohibits Most Indoor Operations**

With the move into the Purple Tier of the State of California's Blueprint for a Safer Economy, several business sectors and activities will have to close or reduce capacity. Transitioning into the most restrictive tier has resulted in these changes:

- Indoor dining prohibited
- Indoor gatherings prohibited (including places of worship, movie showings, weddings, funerals, and events)
- Indoor operations of gyms and fitness centers prohibited
- Indoor retail (including shopping malls) must reduce capacity to a maximum of 25%
- Grocery stores must reduce capacity to a maximum of 50%
- Indoor pools must close
- Indoor family entertainment centers (such as bowling alleys) must close
- Indoor cardrooms must close
- Indoor museums, zoos, and aquariums must close
- Wineries must close indoor operations
- Outdoor bars, breweries, and distilleries must close, unless they are functioning as a restaurant and providing meals
- Personal care services (e.g. hair salons and barber shops; nail care; body art, tattoo, and piercing shops; esthetician, skin care, and cosmetology services; electrology, waxing, threading, and other hair removal services) must limit the number of people entering the facility to allow individuals to easily maintain six feet of physical distance from one another at all times

The County has also enacted a new [Mandatory Directive on Capacity Limitations](#) with some

additional capacity limitations for businesses and activities. Find detailed information in the County's [Revised Risk Reduction Order](#).

## Sanitizer Stations at Varian and Hoover Parks

On November 6, the City of Cupertino's Public Works Department completed the installation of hand sanitizer stations at play structures at both Varian and Hoover parks. This installation was done to comply with the October 28 State Order opening playgrounds for play. Both of these parks are well-frequented and neither location has restrooms on site. Other playground locations were considered for sanitizer stations, but due to expected use and cost to maintain the stations, only Varian and Hoover Parks were selected at this time. In addition, all City playgrounds have been updated with signage that outlines the maximum number of children allowed at each site as well as all required COVID-19 protocols. Although the County has recently been moved back to the Purple Tier, COVID-19 safety protocols at the play structures remain the same. To see those safety protocols, view the attachment below.

## Compost Site Closed for 2020 Season

The City's compost site closed for the 2020 season on Saturday, November 14. The site is typically open from the last weekend in March to the last weekend in October, weather permitting as the site is prone to closure with wet and muddy conditions. This year proved to be challenging with COVID-19 delaying the opening until May. Additionally, the site was closed through several weekends due to the unhealthy air quality from wildfires. In result, the site was open for two additional weekends in November but had to be closed for two of the four days due to rain and mud at the site.

The site was popular on the days it was open this year, hosting more visitors than last year, despite losing so many days. This season, 1,933 residents collected a total of 745 yards of compost for their landscape and gardens. Last season, 1,502 residents collected 680 yards of compost.



The compost is comprised of yard and food waste from residential homes. That waste is processed by South Valley Organics (SVO), a Recology-owned composting facility. Through the Solid Waste Franchise Agreement, SVO provides the City with bulk compost for this program at no additional cost and the City offers it to the community at no charge. We look forward to reopening the compost site in March 2021.

## **Cupertino Launches Climate Victory Gardens Project for Residents**

During the First and Second World Wars, Americans across the country were asked to garden to help with the food shortage crisis and to boost morale by planting what were called Victory Gardens. Now, we are facing a new type of crisis—a warmer and dryer California.

The City of Cupertino is encouraging single-family and multi-family residents to be part of the solution by installing a Climate Victory Garden in their front yards. With help from our ecology experts, you can reduce the demand for water, store carbon in your soil, and save money easier than ever before.

The City's Sustainability Department has partnered with Ecology Action to offer a concierge service at no cost to participants to walk property owners through the steps to a new drought-tolerant yard:

1. The process starts with a free site inspection at the property.
2. Ecology Action's design team will create a custom planting and irrigation design with the property owner.
3. Participants can choose from Ecology Action's pre-vetted, qualified contractors to complete their landscaping project at an affordable rate. Ecology Action will also provide hands-on assistance for participants who decide to make it a Do-It-Yourself (DIY) project.
4. Participants can select from additional features such as advanced irrigation controls, laundry to landscape grey water systems, rain barrels, and pervious paving.
5. After the installation is finished, Ecology Action will help participants apply for rebates to keep the costs down.

## Cupertino's Street Network Rated Highest in Santa Clara County

The Bay Area Metropolitan Transportation Commission has released Pavement Condition Index (PCI) data for all cities in the nine-county Bay Area region. For 2019, Cupertino received a PCI value of 85 out of 100, bringing the City's three-year running average to 84. With a PCI of 85, Cupertino now has highest rated street network in Santa Clara County and second highest three-year running average in the region. Over the past several years, the City has implemented an aggressive maintenance program to improve the condition of our street network. With a PCI of 85, the City will be able to maintain the street network by applying a variety of less-costly preventative maintenance treatments as opposed to more costly structural treatments. By applying the right treatment at the right time, annual expenditures are reduced and PCI can be maintained. View the attachment below to see the PCI data for Santa Clara County.

### **Info-Teeno: Understanding Credit**

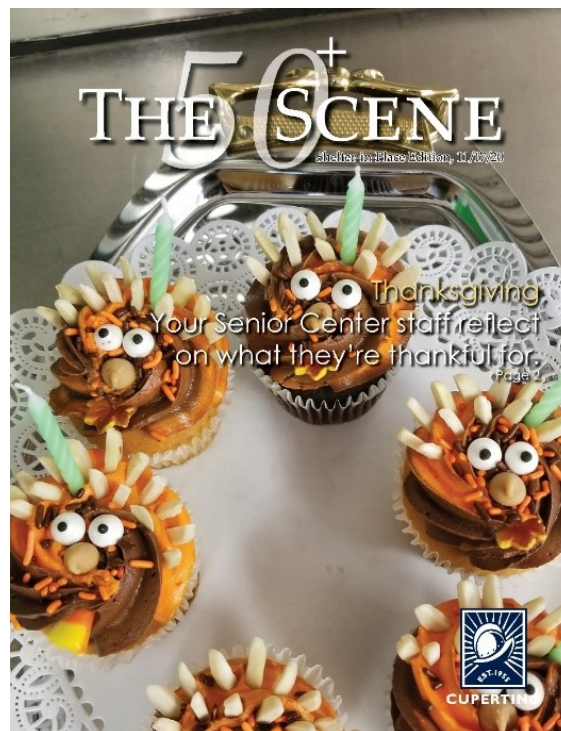

### **The 50+ Scene: Shelter-in-Place Edition**

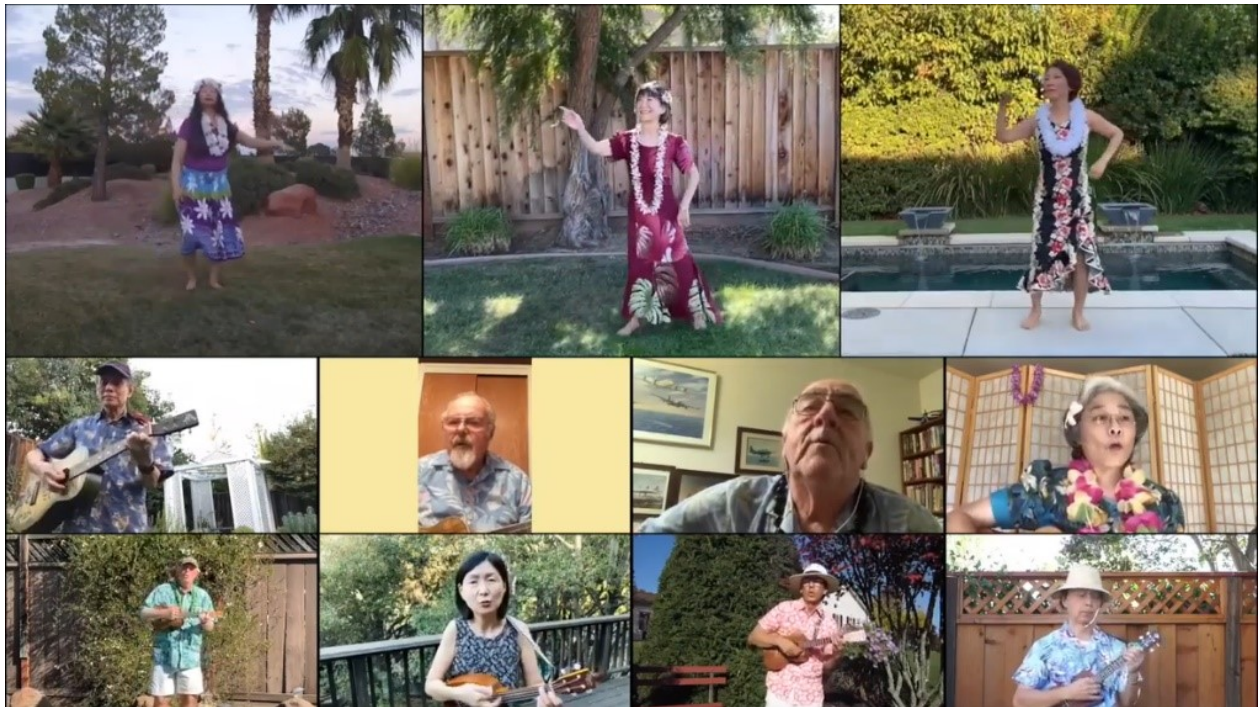
