4/10	C5	Theft by False Pretenses	Between 2/23 and 4/1, unknown suspect(s) befriended the victim online and ultimately convinced the victim to invest money in a fictitious cryptocurrency trading platform for a total loss of about \$141,000. The victim lives in Cupertino.

The suspect then brandished a knife, threatened the victim, and swung the knife at the victim, causing a minor laceration. The suspect also demanded and stole the victim's cellular phone before fleeing the scene, driving off in the victim's vehicle. Deputies located and attempted to stop the vehicle, but the suspect did not yield and recklessly evaded, crashing into several vehicles. The vehicle became disabled after the suspect crashed into a tree. Further investigation revealed the suspect was also unlicensed and in possession of Cocaine. The suspect was arrested, transported to the hospital for injuries sustained from the collision, and will be booked into Main Jail after medical clearance.
