2/20	C9	Petty Theft	At 5:09 AM on 2/15, two unknown suspects cut a lock and stole a bicycle secured to a bike rack in the underground parking garage of an apartment complex in the 20000 block of Town Center Lane for a total loss of about \$598.
2/20	C7	Theft by False Pretenses	At 1:32 PM, unknown suspect(s) spoofed a Sheriff's Office phone number, posed as a lieutenant, claimed there was an arrest warrant for the victim, and instructed the victim to provide money via barcodes texted to the victim. The victim was instructed to remain on the phone the entire time and to not tell anyone about the transaction. The victim withdrew cash and used the barcodes at a drugstore to transfer money to the suspect(s) for a total loss of about \$4,000. The victim lives in Cupertino.

2/24	C3	Residential Burglary	Between 10:30 AM and 10:30 PM, unknown suspect(s) entered a residence in the 20000 block of Dunbar Drive by breaking a sliding glass door and stole car keys, cash and jewelry valued at \$200,000.

The suspect driver, who violated probation terms, was arrested, and booked into Main Jail. The suspect passenger is unknown and at large.
