You will then be emailed instructions on how to connect to the meeting. Your email address will not be disclosed to the public.

3) Members of the public will automatically have their audio and video turned off. If you wish to speak, click on "raise hand." Speakers will be notified shortly before they are called to speak.

Program partners such as designated SR2S parent champions, high school student representatives, school and district staff liaisons, and community organization representatives who we work with will receive a separate invitation to join the meeting as a panelist. Panelists have the ability to turn on their audio and video.
