Overview: Crossing Guard Services

- 16 guards throughout the City of Cupertino
- Cupertino Safe Routes to School manages
 contract
- All City Management Services, Inc(ACMS)
 provides services

Funding

- Funding for guards comes from:
 - Cupertino General Fund
 - FUHSD
 - CUSD

Crossing Guard Warrant Study Process

- Cycle: approximately every 2 years
- Most recent study conducted in two parts:
 - Spring 2022
 - Fall 2022

Crossing Guard Warrant Study Process

- 30 Locations Studied
 - Locations currently served (15)
 - Locations identified in Walk Audits (5)
 - Locations requested by community (9)
 - Location previously served (1)

- Locations ranked based on:
 - Data
 - Other Considerations

Data

- Pedestrian Counts
- Vehicle Counts
- Ped/Vehicle Conflicts

Other Considerations

- Type of Intersection (flashing beacon, signal, stop, uncontrolled)
- Observations
- Number of adults vs. students
- Discussions with Traffic Deputies, CUSD, FUHSD
