Solicitor Permit Application Instructions

The following instructions explain the process of obtaining a solicitor permit. Please read carefully.

- 1. Complete the solicitor permit application.
- 2. Schedule an appointment with code enforcement staff to submit the completed permit application. A digital photograph of the applicant will be taken during the appointment and used for the permit identification card.
- 3. After review of the permit application by the Code Enforcement staff, payment of the permit application fee is due. The business license fee (if applicable) is due upon approval of the permit.
- 4. Schedule an appointment to be fingerprinted with an approved Livescan vendor. Upon completion of fingerprinting, the application may take up to thirty days to be processed.
- 5. After a successful background investigation has been completed and all fees have been paid, the permit will be issued to the applicant. Once the permit has been issued, solicitation may begin.

Not for profit solicitors

No fee will be assessed if current documentation from the IRS or State Franchise Tax Board supports the claim of not-for-profit status. All applicants should obtain a tax- exempt Cupertino business license.
